I, the undersigned, certify that the birds comprising the flock of origin meet the following requirements:

- a) vaccination of poultry for avian influenza is not permitted in the UK and the flock(s) of origin have not been vaccinated against avian influenza;
- b) The flocks of origin have been resident in the UK for at least 90 days or since hatching;
- c) the farm(s) of origin are subject to regular official veterinary inspection there has been no evidence of clinical symptoms of infectious disease at the farm(s) of origin during the 90 days immediately prior to shipment;
- d) the flock(s) of origin are subject to routine veterinary supervision and there has been no evidence of the following diseases during the 6 months immediately prior to export:
Avian Pseudotuberculosis, Avian tuberculosis, Infectious coryza, Newcastle disease (ND), fowl pox, fowl cholera (Pasteurella multocida), fowl typhoid (Salmonella gallinarum), pullorum disease (Salmonella pullorum), infectious bronchitis (IB), Infectious Laryngotracheitis (ILT), infectious synovitis, infectious bursal disease (IBD), egg drop syndrome, ornithosis, Marek's disease, lymphoid leucosis, mycoplasmosis, chronic respiratory disease (CRD), swollen head syndrome, avian nephritis, chick anaemia agent, leucocytozoonosis, avian spirochaetosis, avian encephalomyelitis, Salmonella enteritidis and Salmonella typhimurium;
- e) The flocks of origin of the hatching eggs have undergone a disease surveillance programme in accordance with EU Directive 2009/158/EC with negative results to serological or bacteriological tests for: **Salmonella pullorum (Pullorum disease) and S.gallinarum (Fowl typhoid); (a copy of the latest laboratory report is attached);**
- f) The flocks of origin of the day-old birds have undergone a disease surveillance programme similar to that required by EU Regulation 2160/2003 with negative results for: **Salmonella enteritidis and S.typhimurium (a copy of the latest laboratory report is attached);**
