- I, the undersigned, certify that:
- a) The country or part of country or state of origin has been free from Rinderpest, peste des petits ruminants, Contagious Bovine Pleuropneumonia and Contagious Caprine Pleuropneumonia for the past twelve (12) months prior to and till the date of export.
- b) United Kingdom law prohibits the sale or supply of milk from cows affected or suspected of being affected with Bovine Spongiform Encephalopathy or Foot and Mouth Disease.
- 2. The raw cows' milk used in the manufacture of the milk and milk product described at I above was obtained from animals which are subject to programmes of examination and testing for Tuberculosis and Brucellosis. United Kingdom law prohibits the sale or supply of milk from cows affected or suspected of being affected with Tuberculosis or Brucellosis.
- 3. The raw milk used in the manufacture of the milk and milk product described at I above is required under United Kingdom and Community Legislation to have been obtained from animals subject to regular veterinary inspections to ensure that they satisfy the following animal health conditions:
 - do not show any symptoms of infectious diseases communicable to human beings through milk;
 - ii) incapable of giving milk abnormal organoleptic characteristics;
 iii) whose general state of health is not impaired by any visible disorder and which are not suffering from any infection of the genital tract with discharge, enteritis with diarrhoea and fever, or a recognisable inflammation of the udder;
 - iv) which do not show any udder wound likely to affect the milk.
- 4. The milk or milk products were processed and packaged in a processing/packaging plant that has been approved for export by the Government Veterinary Authority of the country of export.
- 5. The milk or milk products were processed, packaged and stored under sanitary condition and do not contain any preservative, colouring matter, residue or any foreign substance or harmful material injurious to health and that every precaution had been taken to prevent contamination during the processing, packaging, storing and handling prior to export.
- 6. *In the case of liquid milk, that the milk has been subjected to pasteurisation, ultra heat treatment or sterilisation and was packed direct into satisfactory clean and sterilised bottle or container.
- 7. In the case of milk or milk products intended for human consumption, that the milk or milk products destined for export to Jamaica are wholesome and fit for human consumption.
