I, the undersigned, certify that the birds/eggs described above meet the following requirements:

- \* a) on (date), being within 24 hours prior to export, I have inspected the day old birds for export and found no evidence of infectious or contagious disease, and in my opinion they are fit for the intended journey;
- b) on (date), being within 28 days prior to export, the birds comprising the flock(s) of origin have been inspected and found to be healthy and free from clinical signs of infectious or contagious disease;
- c) the flocks of origin and the hatchery are members of the government supervised Poultry Health Scheme, and as such they have been routinely tested for the following diseases throughout the life of the flock with negative results in each case:
  - (i)\* in the case of chickens:  
**Salmonella pullorum, Salmonella gallinarum, Mycoplasma gallisepticum;**
  - (ii)\* in the case of turkeys:  
**Salmonella pullorum, Salmonella gallinarum, Salmonella arizonae, Mycoplasma gallisepticum, Mycoplasma meleagridis;**
- d) no outbreak of **Newcastle disease** has been confirmed in poultry at the premises of origin or within a radius of 25 kms thereof during the past 6 months.
- e) \*neither the flocks of origin \*nor the hatchery are situated in any zone of the United Kingdom which is under animal health restrictions because of an outbreak of **highly pathogenic avian influenza (HPAI)**.
