I, the undersigned official veterinarian, certify that the hatching eggs/day-old ducklings described above meet the following requirements:

which is officially free from **Newcastle disease** according to the criteria of the OIE;

- c) The flocks of origin have undergone a disease surveillance programme in accordance with EU Directive 2009/158/EC with negative results for: **Salmonella pullorum, S.gallinarum;**
- d) The flocks of origin have undergone a disease surveillance programme similar to that laid down in EU Regulation 2160/2003 with negative results for: **Salmonella enteritidis, S.typhimurium;**
- e) the flocks of origin are subject to routine monthly veterinary inspection in accordance with EU Directive 2009/158/EC governing intra-Community trade in live poultry and do not show any signs or suspicion of contagious disease;
- *f) I have this day inspected the said day-old ducklings and found them to be free from clinical signs of disease and fit for the intended journey;
- g) The boxes in which the eggs/birds are packed for export are new, unused and clean, and contain only the birds certified in this certificate;
- h) The vehicles for the transport of the eggs/birds have been cleaned and disinfected prior to use in accordance with EU legislation.
