I, the undersigned, Official Veterinarian, certify that the birds*/eggs* described above meet the following requirements:

- a) The establishments of origin of the birds/eggs are members of a Government supervised poultry health scheme and are under regular supervision by the veterinary authorities of the United Kingdom;
- b) The birds/eggs come from establishments free from **avian mycoplasmosis** (*M. gallisepticum*, *M. synoviae*), **Pullorum disease**, **Infectious Laryngotracheitis (ILT)**;
- c) *(applies only to day-old birds; delete in case of hatching eggs) The hatchery of origin of the day-old birds complies with the standards referred to in Chapter 6.4 of the OIE Terrestrial Animal Health Code and are considered free from **Infectious Laryngotracheitis (ILT)**;

- h) *(applies only to day-old birds; delete in case of hatching eggs) the day-old birds in this consignment have been inspected within 24 prior to shipment and found to be free from clinical signs of infectious disease;
- i) *(applies only to hatching eggs; delete in the case of day-old birds) the hatching eggs for export have been disinfected in accordance with the standards of Chapter 6.4 of the OIE Terrestrial Animal Health Code;
- j) the boxes in which the eggs/birds are packed for export are new, unused and clean, and contain only the eggs/birds certified in this certificate;
- k) on the basis of a declaration by the exporter the consignment for export will be transported to the place of shipment in suitable vehicles which have been cleansed and disinfected prior to loading of the consignment and the birds/eggs will not have contact with other birds/eggs of lesser animal health guarantees;
- l) no outbreak of **Newcastle disease** or **avian influenza** has been confirmed in poultry at the farm of origin and within a radius of 10kms thereof during the past 3 months.
