

EXPORT OF DOGS AND CATS FROM THE UNITED KINGDOM TO THE REPUBLIC OF CAMEROON

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

**IMPORTANT**

These notes provide guidance to Official Veterinarians (OVs) and exporters. The NFG should have been issued to you together with export certificate 3038EHC. The NFG should not be read as a standalone document but in conjunction with certificate 3038EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. **Scope of the certificate**

Export health certificate 3038EHC may be used for the export of dogs and cats from the United Kingdom to the Republic of Cameroon.

2. **Certification by an Official Veterinarian (OV)**

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government or the Welsh Government, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary)(OCQ(V)) authorisation, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture, Environment and Rural Affairs - Northern Ireland (DAERA).

OVs/AVIs should sign and stamp the health certificate with the OV/AVI stamp in any colour **OTHER THAN BLACK**.

A certified copy of the completed certificate must be sent to the issuing office (in GB - the Centre for International Trade, Carlisle) within seven days of signing, or in the case of Northern Ireland, to DAERA, Dundonald House, Belfast.

The OV/AVI should keep a copy for his/her own records.

3. **Rabies vaccination**

Paragraph III. (b) refers. A copy of the rabies vaccination certificate must be attached to the export health certificate.

4. **Travelling through other countries**

It is the responsibility of the exporter/agent to apply to the relevant authorities of the countries shown at paragraph 3 of EXA 1 for permission to transport the animals through these countries. Additional health certification may be necessary.

5. **Welfare**

Welfare conditions during transport are laid down by Council Regulation EC 1/2005, implemented in England by The Welfare of Animals (Transport) (England) Order 2006, and parallel legislation in Scotland, Wales, and Northern Ireland.

Exporters must comply with the UK welfare laws relating to the export of animals. If transported by air, animals should be transported in accordance with International Air Transport Association (IATA) standards.
