7. RABIES NEUTRALIZING ANTIBODY TITRE TEST [RNATI]

The RNATT has been done at least 180 days and not more than 335 days prior to export and has a positive result of at least 0.5IU/ml. The RNATT is only valid for 1 year (365 days) from the date of blood collection.

8. LABORATORY TESTING

8.1. Ehrlichiosis

fluorescent antibody test (IFAT), on a sample collected within 45 days prior to export to Fiji, with negative results.

certify that:

1. Within two (2) days of the scheduled date of shipment, I examined the animal as identified in the attached Veterinary Health Certificate A for exporting to Fiji
2. The animal is identified with an implanted microchip number as:
3. The animal is found to be free from clinical signs of infectious or contagious diseases and free from external parasites and fit to travel.
4. Rabies is a compulsorily notifiable disease in United Kingdom, and an effective system of rabies surveillance is in place.
5. All regulatory measures for the prevention and control of rabies have been implemented and maintained.
6. No case of rabies has been detected in any location housing the animal for export or within a 10-mile radius in the previous 12 months.
7. The animal was vaccinated against rabies and tested by the RNATT test with a protective antibody test of 0.5 IU per ml.
8. All the required documents were examined and found to be correctly completed in accordance with Fiji's zoo-sanitary requirements as listed on the import permit.
9. All laboratory reports or copies have been endorsed by me and are attached to Veterinary Health Certificate A.
