

### III. Health Information

- I, the undersigned, certify that:
- a) I have received a declaration from the owner/exporter that the animal to be exported has been in continuous residence in the UK at least 6 months prior to export to Mauritius;
- b) if a female dog it is NOT PREGNANT;
- c) the dog has been sterilised/neutered;
- d) within 48 hours prior to export, the dog is in good health and free from clinical signs of contagious and infectious disease and external parasites and is fit to travel;
- e) the animal is identified with a microchip or permanent tattoo and the identification details must be shown on the accompanying certification. It is recommended that microchip brands should confirm to the International Standards Organisation (ISO) standard 11784 or to ISO Standard 11785;
- f) the dog is not one of the following breeds that are on the list of breeds banned by the Ministry of Agro-Industry and Food Security in Mauritius;
  - Dogo Argentino
  - Fila Braziliero
  - Japanese Tosa
  - American Pit Bull Terrier
  - American Staffordshire Terrier
  - Staffordshire Terrier
  - Blue Nose Pit Bull
  - Red Nose Pit Bull
  - Boerboel
- g) the dog has been vaccinated against rabies with an inactivated vaccine (of at least one international antigenic unit) when at least three months of age and at least two months before export except in case of booster vaccination 30 days prior to export. A copy of the Rabies vaccination certificate for the most recent vaccination must be attached to export veterinary certificates;
- h) the dog has been subjected to a neutralising antibody titration test for rabies antibodies in accordance with one of the methods described in the OIE Manual of Standards for diagnostic tests and vaccines, and found to have at least 0.5 IU/ml) of antibody in its serum. The test must be performed at least one month and not more than 6 months prior to export. The laboratory result forms must clearly identify the animal to be imported, using the microchip transponder/tattoo identification number of the animal. This assessment has been done in a government approved laboratory and the results are attached to this certificate;

- i) a letter from the dog's veterinarian is attached stating the date blood was taken from the animal for the laboratory testing detailed in III (h);
