Declaration

Submitting Sections A to H

The Word template should be between 50 and 100 pages long (depending on which type of group you are); formatted for printing on A4 paper; completed in Arial 12 point font; and include page numbers. The contents of the budget Excel template and Excel application form are excluded from the page limit.

Please include the name of your school in the file name for all Word and Excel templates.

Section C1 – a credible proposal to deliver a high-quality free school and a clear rationale for establishing it in this area

This is an application to open a 6 FE Boys 11-18 free school very similar to the provision in our open schools at Harris Invictus Croydon and in Tottenham, and our schools in preopening in Wimbledon and West Thurrock. It will also be modelled on the successful provision at Harris Boys Academy East Dulwich. The Royal Borough of Greenwich had a forecast shortfall of 15 FE of demand for secondary places by 2021/22, prior to the Wave 11 approvals. Wave 11 has agreed an 8 FE Girls School to open in the Borough, but this still leave 7 FE of unmet demand and critically the Girls School approval leaves an imbalance of places between boys and girls. We have therefore agreed with Greenwich that we will make an application for a Boys School to redress this.

We do have secondary schools close to our proposed site with Harris Academy Greenwich nearby; and Harris Academy Falconwood a little further away. So we have other Schools well placed to support the start up of a new Free School.

All of our secondary schools are Good or Outstanding and 75% of them are Outstanding. This is a record unmatched by any MAT. We believe that we can use our existing schools to support this new school to be successful quickly.

This proposed free school would be founded on the same principles as our Free Schools at Harris Invictus Croydon and Harris Academy Tottenham. It would also use the methodologies that we have put in place at Harris Boys Academy East Dulwich, which is Outstanding and Chobham Academy, which we operate, and which has achieved Outstanding in all categories in its first OFSTED. DFE colleagues know that our ethos and approaches are tried and tested and that we will open and operate an Outstanding School.

The school would at this stage be proposed to be 11-18. It is important for us that our students have the opportunity to obtain their A levels or Level 3 BTECs with us and

have the benefit of the exceptional programmes we run to encourage them to apply and obtain places at top universities. But if site restrictions mean we cannot fit a sixth form here we may be able to provide places at our other local schools and expand their sixth forms. We accept that post 16 provision will to some extent be subject to the current Area Review.

For those who are not assessed as able to take triple Science we will provide 6 lessons of Science and provide additional Maths and English

Harris Federation has used its resources to work innovatively to design schemes of work in all subjects and to track back from expected new GCSE scores in 5 years time to give assessment tools to teachers that enable them to set stretching targets and to assess their students progress towards GCSE from Year 7 upwards. Students' progress is monitored half termly with reports home to parents and individual interventions with those children not making the progress expected.

All Harris Secondary Schools in 2016 achieved positive Progress 8 VA scores with an average across the Group of +0.66. Harris Boys Academy East Dulwich performed just above the Group average at +0.70.

<p>We have discussed the need with Greenwich LA. They tell us that after allowing for the 8 FE girls free school agreed in Wave 11 to proceed into preopening they still will have a 7 FE shortfall by 2021/22</p> <p>So there is basic need for more than the 6 FE we are proposing and an imbalance of provision will exist between boys and girls with the additional 8 FE of girls places agreed in Wave 11. This proposal will largely redress that imbalance.</p> <p>The demand for places at Harris schools is high with over 4 applications on average for each place.</p> <p>Harris Academy Greenwich has been transformed and is now heavily oversubscribed. It received 1291 applications for 180 places for admission in 2016 with 312 being first preference and 601 being first to third preferences. So there is clear demand for a Harris education at Year 7 from local parents.</p>
