IV. Health Certification:

I, the undersigned, certify that the poultry meat/poultry meat products described above meet the following requirements:

- (a) Highly Pathogenic Avian Influenza (HPAI) is a notifiable disease in the United Kingdom;
- (b) the poultry meat/poultry meat products are derived from poultry which have been subjected to ante-mortem and post-mortem inspection and found to be free from any clinical evidence of infectious and contagious diseases; Ante-mortem and post-mortem inspections have been carried out by veterinarians or meat inspectors under direct supervision of government veterinarians.
- (c) the poultry meat/poultry meat products have been inspected and found fit for human consumption, and every precaution has been taken to prevent contamination prior to export;
- (d) the poultry meat/poultry meat products have been dressed, prepared and packed under hygienic conditions in accordance with regulations at present in force in the United Kingdom, and kept free from contamination prior to export;
- (e) the poultry meat/poultry meat products were derived from poultry which were slaughtered, processed, packed and stored under sanitary conditions under official supervision in the above-mentioned establishments, which are approved by the relevant competent authority in the United Kingdom to export without restriction to other Member States of the European Union, and are approved by the Director-General, Food administration for export to Singapore;
- (f) *EITHER (i) the UK has been free from HPAI for the past 28 days prior to export, following a stamping out policy in accordance with Article 10.4.6 of OIE Terrestrial Animal Health Code;
 - *OR (ii) the poultry meat/poultry meat products were not derived from birds originating from areas within the 10 km surveillance zone(s) around any infected premises in the UK established due to an outbreak of HPAI in poultry according to the definition of the OIE Terrestrial Code;
 - ***OR** (iii) the poultry meat/poultry meat products have been heat-treated or processed attaining a core temperature of °C for a minimum time period of

- (g) the meat was derived from poultry that were born, raised and slaughtered in the United Kingdom or were legally imported into the UK as day old chicks from countries with equivalent poultry health status;
- (h) the meat has not been treated with chemical preservatives or foreign substances injurious to health;

(i) the birds from which the meat was sourced were not vaccinated against H5 and H7 subtypes of avian influenza (AI), as defined by the World Organisation for Animal Health (OIE).
