

EXPORT OF DOGS AND CATS FROM GREAT BRITAIN TO MOZAMBIQUE

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The Notes for Guidance (NFG) should have been issued to you together with export certificate 4143EHC. The NFG should not be read as a standalone document but in conjunction with certificate 4143EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. **SUMMARY OF REQUIREMENTS**

- Export health certificate issued by DEFRA;
- Animals must be examined by the OFFICIAL VETERINARIAN not more than 48 hours prior to export;
- All cats and dogs must be vaccinated against rabies not less than 30 days and not more than 12 months prior to export.

2. **CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)**

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government or the Welsh Government, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary)(OCQ(V)) authorisation, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture, Environment and Rural Affairs - Northern Ireland (DAERA).

OVs/AVIs should sign and stamp the health certificate with the OV/AVI stamp in any colour **OTHER THAN BLACK**.

A certified copy of the completed certificate must be sent to the issuing office (in GB - the Centre for International Trade, Carlisle) within seven days of signing, or in the case of Northern Ireland, to DAERA, Dundonald House, Belfast.

The OV/AVI should keep a copy for his/her own records.

3. **RABIES VACCINATION**

Rabies vaccination must be given at least 30 days and not more than 12 months prior to export. A rabies vaccination certificate should be completed by a veterinary surgeon who vaccinates the animals.

4. **NOTIFIABLE DISEASE CLEARANCE**

Paragraphs III (c) and (e) refer. These paragraphs may be certified provided written authority to do so has been obtained on form 618NDC from the issuing office.

4. **TRAVELLING THROUGH OTHER COUNTRIES**

It is the responsibility of the exporter/agent to apply to the relevant authorities of any transit countries for permission to transport the animals through these countries. Additional health certification may be necessary.

5. **WELFARE DURING TRAVEL**

Welfare conditions during transport are laid down by Council Regulation EC 1/2005, implemented in England by The Welfare of

Animals (Transport) (England) Order 2006, and parallel legislation in Scotland, Wales, and Northern Ireland.

Exporters must comply with the UK welfare laws relating to the export of animals. If transported by air, animals should be transported in accordance with International Air Transport Association (IATA) standards.
