I, the undersigned, hereby certify that:

- (a) the pet food and the ingredients of animal origin come from a country or a part of a country which has been free from foot and mouth disease (FMD), rinderpest, contagious bovine pleuropneumonia, classical swine fever, African swine fever and swine vesicular disease during the last 12 months prior to date of export;
- (b) in the case of petfood containing ingredients of bovine origin, the petfood comes from a country or a part of a country which has a Negligible or a Controlled bovine spongiform encephalopathy (BSE) risk in accordance with the Terrestrial Animal Health Code (OIE) or was manufactured using ingredients of bovine origin which were legally imported from a country or a part of a country which has a Negligible bovine spongiform encephalopathy (BSE) risk;

- (c) in the case of petfood containing ingredients of ovine and caprine origin, the petfood comes from a country or a part of a country which is free from scrapie or was manufactured using ingredients of ovine and caprine origin which were legally imported from a country or a part of a country which is free from scrapie;
  - (d) in the case of petfood containing ingredients of cervidae origin (deer, elk, moose, etc), the petfood comes from a country or a part of a country which is free from chronic wasting disease or was manufactured from ingredients of cervidae origin which were legally imported from country which is free from chronic wasting disease;
  - (e) in the case of petfood containing ingredients of poultry origin, the ingredients of poultry origin have been sufficiently heat treated to destroy the avian influenza and Newcastle disease viruses;
  - (f) the petfood contains no ingredients of ruminant origin except as noted below:
    - i milk or dairy ingredients;
    - ii protein free tallow (maximum level of insoluble impurities of 0.15% in weight);
    - iii gelatine or collagen derived exclusively from hides;
    - iv hides or hide-derived ingredients other than gelatine or collagen;
    - v ruminant ingredients legally imported into the United Kingdom;
    - vi bovine ingredients that were not derived from and do not contain the following Specified Risk Materials (SRM): the brain, skull, eyes, trigeminal ganglia, vertebral column, and dorsal root ganglia from cattle over 30 months of age or the tonsils and distal ileum of the small intestine from cattle of any age;
    - vii bovine ingredients that originated from slaughtered animals which were subjected to ante and post mortem inspection by the competent veterinary authority;
    - viii bovine ingredients that have been heat treated for at least 20
      minutes at a temperature of at least 133°C at a pressure of 3
      bar absolute with 50 mm particle size;
  - (g) the animal material used is subjected to the following treatments:
    - i the material used for dry products has been subjected to heat treatment to a minimum of 80°C throughout their substance;
    - ii canned petfood has been subjected to a heat treatment to a minimum Fo value of 3.0 or more;
  - (h) all reasonable precautions have been taken after processing to avoid contamination of the finished product with pathogens;
  - dry, semi-moist and dehydrated products were sufficiently heat processed to ensure the destruction of pathogens;
  - (j) the manufacturing plant is approved by the government as producer of petfood for export to Indonesia;
  - (k) the products certified herein are officially authorised for sale and use as petfood in the United Kingdom;

- (1) all products have been packed using new containers and packaging materials;
- (m) visibly damaged bags or packages or boxes and unsafe boxes/containers have been removed from the consignment before loading;
- (n) the petfood packaging or can specifically and clearly describes the ingredients used and the expiry date;
- (o) the container used for transporting the petfood is in a sanitary condition.
- (p) I have received a declaration from the exporter stating that the products described at paragraph I above will be:
  - \*transported directly from the \*port / \*airport described at paragraph
    III(c) directly to the port of entry in Indonesia, or:
  - \*will be transported via another country for which approval has been provided from the Director General of livestock services in Indonesia.
