IV. HEALTH INFORMATION

I, the undersigned, hereby certify that:

- 1. the United Kingdom has been free from foot and mouth disease, anthrax, peste de petits ruminants, lumpy skin disease, sheep/goat pox, and African and classical swine fever for the past six (6) months immediately prior to export;
- 2. the wool, hair or bristles originated from animals that, at the time of shearing, were part of a flock that was not subject to movement restrictions for the control of anthrax;
- 3. for wool, hair and bristles from foot and mouth disease susceptible animals, these products have been processed to ensure the destruction of the foot and mouth disease virus in accordance with one of the following procedures:

EITHER

*3.1 in the case of wool or hair:

either

- *i. industrial washing which consists of immersion of the wool in a series of baths of water, soap and sodium hydroxide (soda) or potassium hydroxide (potash);
- or**
- *ii. chemical depilation by means of slaked lime or sodium sulphate;
- or**
- *iii. fumigation in formaldehyde in a hermetically sealed container or chamber for at least 24 hours;
- or**
- *iv. industrial scouring by means of immersion of wool in a water-soluble detergent held at 60-70°C;
- or**
- *v. storage of wool at 4°C for four months, 18°C for four weeks or 37°C for eight days;

AND/OR

*3.2 in the case of bristles:

either

- *i. boiling for at least one hour;
- or**
- *ii. immersion for at least 24 hours in a 1% aqueous solution of formaldehyde.
