I the undersigned, certify that:

3. the product was manufactured in a plant:

* (a) dedicated to the production of non-ruminant feedingstuffs;

* (b) which complies with the following conditions:

- the transport and storage of feed materials destined to ruminant animals is completely separate from feed material prohibited for feeding to ruminant animals, and
- the storage, transport, manufacturing and packaging facilities for the compound feedingstuffs destined to ruminant animals are completely separate, and
- records detailing the purchases and uses of fishmeal and the sales of feedingstuff containing fishmeal are made available to the competent authority, and
- routine tests are carried out on feeding stuffs destined to ruminant animals to ensure that prohibited processed animal proteins as defined by Article 1 of Decision 2000/766/EC are not present;

4. the product does not contain any other processed animal protein, as defined by Article 1 of Council Decision 2000/766/EC⁽¹⁾;

(1) Commission Decision 2000/766/EC defines processed animal protein as: meat-and-bone meal, meat meal, bone meal, blood meal, dried plasma and other blood products, hydrolysed proteins, hoof meal, horn meal, poultry offal meal, feather meal, dry greaves, fishmeal, dicalcium phosphate, gelatine and any other similar products including mixtures, feedingstuffs, feed additives and premixtures, containing these products.
