I, the undersigned, certify that the birds described above meet the following requirements:

- a) on _____ (date), being within 5 days of the date of export, I inspected the flock of origin and the birds for export and found them to be free from clinical signs of infectious or contagious disease, and no evidence of exposure to the following diseases was found:
 Newcastle disease, infectious coryza, infectious laryngotracheitis, fowl cholera, highly pathogenic avian influenza (fowl plague), fowl pox, fowl typhoid, pullorum disease, tuberculosis, egg drop syndrome virus (EDS '76), Arizona disease, ornithosis, *Mycoplasma gallisepticum*, *Mycoplasma synoviae*, avian encephalomyelitis, avian infectious bronchitis, Marek's disease, infectious bursal disease, duck virus hepatitis or duck virus enteritis (duck plague);
- b) no outbreak of Newcastle disease or highly pathogenic avian influenza has been confirmed by the Department at the premises of origin or within a radius of 60 km thereof during the past 6 months;
- c) on _____, being within 6 months of shipment, blood samples sufficient in number to give 95% confidence of detecting a 5% prevalence of disease, were collected at random from a representative sample of the flock(s) of origin and were submitted to the Veterinary Laboratories Agency (VLA) Weybridge/Lasswade or the Institute of Biosciences, Stormont where they were submitted to tests for the following diseases:
Salmonella pullorum, *salmonella enteriditis*, *Mycoplasma gallisepticum* and *Mycoplasma synoviae* with negative results in each case;
- d) within the last 10 days prior to export each of the birds for export has been treated with products authorised by Defra for both **internal** and **external parasites** according to the manufacturers' instructions

- e) I have received a written declaration from the owner/exporter stating that:
 - (i) the birds will be packed for export in clean, new containers;
