EXPORT OF CATS AND DOGS FROM GREAT BRITAIN TO BOLIVIA

NOTES FOR GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

# IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The Notes for Guidance (NFG) should have been issued to you together with export certificate 3892EHC. The NFG should not be read as a standalone document but in conjunction with certificate 3892EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

### 1. SUMMARY OF REQUIREMENTS

- Import permit from the Bolivian authorities;
- Export health certificate issued by DEFRA;
- A written declaration must be received from the exporter stating that the animal has been resident in Great Britain for the past six months or since birth;
- All dogs and cats must be vaccinated against rabies not less than 30 days and not more than 12 months prior to export;
- Animals must be examined by a Official Veterinarian not more than 96 hours prior to export;
- Once the export health certificate has been completed and signed by the Official Veterinarian it must be taken or sent for legalisation to the Legalisation Sections of the Foreign and Commonwealth Office and the Bolivian Embassy in London.

# 2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government or the Welsh Government, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary)(OCQ(V)) authorisation, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture, Environment and Rural Affairs - Northern Ireland (DAERA).

OVs/AVIs should sign and stamp the health certificate with the OV/AVI stamp in any colour **OTHER THAN BLACK**.

A certified copy of the completed certificate must be sent to the issuing office (in GB - the Centre for International Trade, Carlisle) within seven days of signing, or in the case of Northern Ireland, to DAERA, Dundonald House, Belfast.

The OV/AVI should keep a copy for his/her own records.

### 3. IMPORT PERMIT

No animal may be imported into Bolivia except in accordance with the terms of an import permit issued by the Veterinary Services Section, Ministerio de Asuntos, Campesinos y Agroperuarios, Piso 4 of 404, Av. Camacho No 1471, La Paz, Bolivia.

# 4. RABIES VACCINATION

The Department of Agriculture in Bolivia require vaccination not less than 30 days and not more than 12 months prior to export. A rabies vaccination certificate must be completed by the veterinary surgeon who administers the vaccine. The use of rabies vaccine is not generally permitted in Great Britain but arrangements have been made for it to be made available for animals intended for export.

# 5. LEGALISATION

Exporters should note that it is their responsibility to arrange for all documents (once completed) to be sent or taken for legalisation to:

- 6. TRAVELLING THROUGH OTHER COUNTRIES The exporter/agent should apply to the relevant authorities of any countries through which the animal(s) will travel for permission to transport the animals through these countries. Additional health certificate(s) may be necessary for these transit countries.
- 7. NOTIFIABLE DISEASE CLEARANCE Paragraph IV d) refers. OFFICIAL VETERINARIANS may certify country freedom from rabies provided written authority to do so has been obtained from the issuing office on form EC618.

# 8. <u>WELFARE DURING TRAVEL</u>

Welfare conditions during transport are laid down by Council Regulation EC 1/2005, implemented in England by The Welfare of Animals (Transport) (England) Order 2006, and parallel legislation in Scotland, Wales, and Northern Ireland.

Exporters must comply with the UK welfare laws relating to the export of animals. If transported by air, animals should be transported in accordance with International Air Transport Association (IATA) standards.
