Non-technical summary

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the London Borough of Camden (LBC) during the month of September 2018.

A number of worksites were active during the reporting month in the LBC area. Demolition was undertaken at the DB Cargo worksite (ref. S001-WS01), along with site establishment works at the former Addison Lee site. Archaeological excavations, foundation construction and encapsulation of structures were underway at St James's Gardens worksite (ref. S003-WS01). Scaffolding and removal of fixtures and fittings were underway at 132 and 140 Hampstead Road and Petrol Station, worksite (ref. S001-WS02) and at the former National Temperance Hospital, 110 Insull Wing worksite (ref. S003-WS02). Taxi ranks construction were undertaken at Euston Square Gardens (west) worksite (ref. S003-WS08). Removal of fixtures and fittings of buildings and utilities disconnections were carried out at Walkden House worksite (ref. S003-WS03) and at Drummond Street / Euston Street worksites (ref.: S003-WS07). Removal of fixtures and fittings of buildings and asbestos removal were carried out at the Thistle Hotel worksite (ref. S003-WS04). Scaffolding and removal of fixtures and fittings were undertaken at the Ibis Hotel, 3 Cardington Street & 1-3 Cobourg Street worksite (ref. S003-WS05), where demolition works also had commenced. Movement of plant, erection of acoustic barriers, installation of walkway, earthworks, dismantling of overhead line equipment, scaffolding and demolition of relay room were underway at Network Rail worksite B. Movement of plant, trial holes digging and excavation of trial trenches, concrete coring, small part steel installation and removal, dismantling of overhead line equipment were underway at Network Rail worksites C, D and E. Further non-intrusive activities were underway at other worksites around Euston Station (worksites ref. S003-WS01, S003-WS06, S003-WS09). Utility diversion works were also undertaken at the north end of Park Village East. Details of works undertaken at each worksite is presented in the report.

Noise monitoring was undertaken in the vicinity of the DB Cargo worksite (ref.: S001-WS01), 132 and 140 Hampstead Road and Petrol Station worksite (ref.: S001-WS02), St James's Gardens worksite (ref.: S003-WS01), Walkden House worksite (ref.: S003-WS03), the Ibis Hotel, 3 Cardington Street & 1-3 Cobourg Street worksite (ref. S003-WS05), former National Temperance Hospital, 110-122 Hampstead Road worksite (ref. S003-WS06), Drummond Street / Euston Street worksites (ref.: S003-WS07), Ibis Hotel, Euston Square Gardens (west) worksite (ref. S003-WS08), the Thistle Hotel (ref. S003-WS04) and Network Rail worksites B, C, D, E and F. Further noise monitoring installations were also installed at Regents Park Estate, in the vicinity of Regents Park Lorry Holding Area, at Edinboro Castle on Mornington Terrace and on Eversholt Street.

Exceedances of the SOAELs were measured at some monitoring positions surrounding worksites S001-WS01, C and D, which were caused by activities at on-network HS2 construction sites outside core working hours. No exceedances of S61 trigger levels due to HS2 related works were measured during the monitoring period. Two complaints were received during the monitoring period. A noise complaint was received regarding noise from a compressor being run outside permitted hours in proximity to S001-WS01 worksite. A vibration complaint was received from a resident living near S001-WS01 worksite and regarding perceptible vibration within the building. Description of the complaints, results of investigation and any action taken are detailed in the report.

Three new noise monitors were installed during September. Location CC was installed on the 1st September at the Camden Carriage side, location N006 on the 12th September at the Royal College of General Practitioners (roof level) and location N016 on the 28th September at the Margarete Centre. Two new vibration monitors were installed on the 17th September at the Royal College of General Practitioners, one in the basement boiler room by Stephenson Way, and one in the basement vaults under Melton Street (V01 & V02 respectively).

Equivalent continuous sound pressure level, or $L_{pAeq,T}$	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.
Façade	A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +2.5 to +3 dB) sound level than it would be if the reflecting surface was not there.
Free-field	A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position.
Exclusion of data	Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, winds speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Equivalent continuous sound pressure level, or $L_{Aeq,T}$	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.
Peak particle velocity, or PPV	Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s.
Sound pressure level	The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud.
Vibration dose value, or VDV	An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s ^{1.75} .

1 Introduction

- 1.1.1 The nominated undertaker is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
 - monitoring the impact of construction works;
 - to investigate complaints, incidents and exceedance of trigger levels; or
 - monitoring the effectiveness of noise and vibration control measures.

Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the London Borough of Camden (LBC) for the period 1st to 30th September 2018.

- 1.1.2 Active construction sites in the local authority area during this period include:
 - Network Rail on-networks HS2 preparatory works: worksite ref. B (see plan 1 in Appendix A)
 - Works activities include movement of plant/equipment/materials by road/rail vehicles, erection of acoustic barriers, installation of walkway, dismantling of overhead line equipment (OLE) structures, back-filling previous excavations, erecting scaffolding around redundant relay room and demolition of redundant relay room.
 - Network Rail on-networks HS2 preparatory works: worksite ref. C, D and E (see plan 2 in Appendix A)
 - Works activities include movement of plant/equipment/materials by road/rail vehicles, removal of scrap, hand dug trial holes, excavating trial trenches, concrete coring, small part steel (SPS) installation and removal, dismantling OLE structures, running cables.
 - DB Cargo shed and adjacent land on Granby Terrace, worksite ref. S001-WS01 (see plan 2 in Appendix A)
 - Works activities include demolition and ancillary activities at the former Addison Lee site.

- 132 and 140 Hampstead Road and Petrol Station, worksite ref. S001-WS02 (see plan 3 in Appendix A)
 - Works activities include scaffolding and removal of fixtures and fittings.
- St James's Gardens, worksite ref. S003-WS01 (see plan 3 in Appendix A)
 - Works activities include archaeological excavations, foundation construction and construction of screening structures.
- Former National Temperance Hospital, Insull Wing, worksite ref. S003-WS02 (see 3 in Appendix A)
 - Works activities include scaffolding and removal of fixtures and fittings.
- Walkden House, 67-75 & 77-79 Euston Rd, worksite ref. S003-WS03 (see plan 3 in Appendix A)
 - Works activities include removal of fixtures and fittings and utilities disconnections.
- Thistle Hotel, Cardington Street, worksite ref. S003-WS04 (see plan 3 in Appendix A)
 - Works activities include removal of fixtures and fittings and asbestos removal.
- Ibis Hotel, 3 Cardington Street & 1-3 Cobourg Street, worksite ref. S003-WS05 (see plan 3 in Appendix A)
 - Works activities include scaffolding, removal of fixtures and fittings and commencement of demolition.
- Former National Temperance Hospital, 110-122 Hampstead Road, worksite ref. S003-WS06 (see plan 3 in Appendix A)
 - Site activities include deliveries.
- 93-103 Drummond Street, 11-15 Melton Street, 54-64 Euston Street, 69 Cobourg Street, worksite ref. S003-WS07 (see plan 3 in Appendix A)
 - Works activities include removal of fixtures and fittings and utilities disconnections.
- Euston Square Gardens (west), worksite ref. S003-WS08 (see plan 3 in Appendix A)
 - Works activities include taxi rank construction.
- One Euston Square, 40 Melton Street, Grant Thornton House, 22 Melton Street, worksite ref. S003-WS09 (see plan 3 in Appendix A)
 - Works activities include removal of fixtures and fittings.
- Further works were also carried out at the north end of Park Village East to divert utilities (including gas, fibre optics and sewers in the area) in preparation for the

main works, planned to start in March 2019. These included breaking out of the road surface and excavations, followed by utility installations and surface reinstatement.

2 Summary of results

2.1 Exceedances of SOAEL

- 2.1.1 The significant observed adverse effect levels (SOAEL) is defined in the Planning Practice Guidance Noise as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."
- 2.1.2 Where construction noise levels exceed the SOAEL, relevant periods will be identified and summary statistics provided in order to evaluate ongoing qualification for noise insulation and temporary rehousing.
- 2.1.3 Table 3 presents a summary of recorded exceedances of the SOAEL due to HS2 related construction noise at each measurement location over the reporting period, including the number of exceedances during each time period.

This monitor is located within the worksite and the measured noise levels and exceedances of the SOAEL are not representative of noise at the surrounding residential properties. This monitor is being relocated to a more representative location on site in closer proximity to nearby residential properties.

2.1.4 Over the reporting period the SOAEL was exceeded at a number of measurement locations in the vicinity of worksites B, C and D. These were caused by activities at Network Rail on-network HS2 construction sites mainly during night-time periods and during weekend days. Outside of these times any exceedances of the SOAEL were caused

Due to the recent installation of a power generator in close proximity to the noise monitor, the measured noise levels and exceedances of the SOAEL due to activities at worksite S001-WS01 are not representative of noise at surrounding areas. This monitor is being relocated to a more representative location on site further from the generator to be more representative of nearby residential properties.

- by the underlying ambient noise levels or other construction activities not related to HS2, rather than being attributable to HS2 construction noise.
- 2.1.5 For the purpose of assessing eligibility for noise insulation or temporary rehousing, multiple exceedances of the SOAEL in a 24-hour period would be counted as a single exceedance during that day. Over the reporting period, the overall number of SOAEL exceedances at each measurement location is shown in Table 4 and may be lower than the total sum of individual exceedances reported in Table 3 for each location.

This monitor is located within the worksite and the measured noise levels and exceedances of the SOAEL are not representative of noise at the surrounding residential properties.

2.1.6 Monitoring of vibration peak particle velocity (PPV) was undertaken with the purpose to ensure construction generated vibration levels were not of such a magnitude to damage adjacent buildings, in accordance with Annex 1: Code of Construction Practice of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements. There are no LOAEL and SOAEL criteria based on PPV applicable to HS2 construction vibration.

2.2 Summary of Measured Noise and Vibration Levels

2.2.1 Table 5 presents a summary of the measured noise levels at each monitoring location over the reporting period. The $L_{Aeq,T}$ is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period $L_{Aeq,T}$ that was found to occur within the month.

Due to the recent installation of a power generator in close proximity to the noise monitor, the measured noise levels and exceedances of the SOAEL due to activities at worksite S001-WS01 are not representative of noise at surrounding areas.

2.2.2 Noise monitoring in the vicinity of worksites S001-WS01, S003-WS01, S003-WS05, S003-WS08, B, C, D and E is considered representative of HS2 Area South works during periods of construction works. Other worksites were not considered to be giving rise to substantial levels of HS2 related construction noise, with the measured noise levels largely dominated by the underlying ambient noise, acknowledging that intermittent HS2 works may on occasion be taking place within the area.

This monitor is located within the worksite and the measured noise levels and exceedances of the SOAEL are not representative of noise at the surrounding residential properties.

Due to the recent installation of a power generator in close proximity to the noise monitor, the measured noise levels are not representative of noise at surrounding residential properties.

2.2.3 Table 7 presents a summary of the measured vibration levels at monitoring locations V01 and V02 over the reporting period. The highest PPV measured during the monitoring along any axis is presented in the table. Exceptionally high values of PPV were measured in the afternoon of Thursday 27th September. These elevated vibration levels are thought to be due to events not related to HS2 works in close proximity to the vibration sensor. The data was not considered representative of HS2 construction vibration levels, because high vibration generating activities were not undertaken at these times. Therefore, these vibration levels have been excluded from the table below.











Vibration
