Thank you for your email dated 23 November 2017 in which you have requested the following information:

The Forty-Sixth Report 2017 of the Armed Forces Pay Review Body states:

"The Review Body shall have regard for the need of the pay of the Armed Forces to be broadly comparable with pay levels in civilian life."

Minimum Wage for those aged 25 and over is set at £7.50/hr since April 2017. Therefore, the minimum lawful rate of pay for civilians working 8 hours is £60.

The rate of pay for Army Reservists for 1 × Reserve Service Day (8-24hrs worked in a 24hr period) starts at £37.47. This only rises above £60 upon promotion or after 5 years service.

I would like to know:-

- To what extent, if any, did the Armed Forces Pay Review Body consider the specific effects the method of calculation of rates of pay for Reserve Service Days has upon the remuneration of Army Reservists?
- How has the Armed Forces Pay Review Body reconciled the above facts in its analysis?
- Has the Armed Forces Pay Review Body formed the conclusion that Army Reservists are paid rates broadly comparable with pay levels in Civilian life? If so, how?
