Thank you for your email of 21 July 2017 requesting the following information:

"Date Range 21.07.2014 to 21.07.2017

How many service personnel have made complaints of any kind of sexual Assault committed against them whilst on any military property in the UK or abroad to include ships subs planes etc or committed against them where the suspect has been another member of the armed services

Notes:

Please break down by service, gender of offender and victim and where possible location."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOI Act).

I can advise you that following a search of our records, I have established that some of the information you requested is held by the Ministry of Defence (MOD).

However, under Section 21 of the FOIA the MOD is not obliged to supply information that is reasonably accessible to the applicant by other means. For the period 1 January 2015 to 31 December 2016, a Section 21 exemption applies as official statistics of all sexual offences reported to the Service Police during that period have been published and can be found at the following link:

For the Period 1 January 2017 to 21 July 2017, Section 22 of the FOIA applies because official statistics for sexual offences in the Service Justice System are now published annually. The next official statistics for the period 1 January 2017 to 31 December 2017 are due to be published in March 2018.

To provide an answer for the remaining period, I can advise that as at 1 August 2014 there were 156,739 Full-Time UK Regular Personnel and 28,201 personnel in the Future Reserves 2020 (these numbers include trained and untrained personnel). During the time 21 July 2014 to 31 December 2014 there were 38 incidents of sexual assault reported to the Service Police across the three Services. Of the 38 incidents, all of the suspects were

male. Please note that the 38 incidents were allegations and not all will have followed through to conviction. The incidents are broken down further in the following tables.

Table A overleaf displays a breakdown by the gender of victims of sexual assault reported to the Service Police in the period 21 July 2014 to 31 December 2014.
