Thank you for your emails of 22 June 2017 requesting the following information:

- "1. Please tell me in the last 5 years how many reported rapes have taken place involving Royal Navy staff [FOI2017/06052] Army staff [FOI2017/06053] Royal Air Force staff [FOI2017/06054]. Please provide the data broken for each year. i.e 2011, 2012, 2013, 2014, 2015 and 2016.
- 2. Please tell me how many of these reported rapes resulted in a charge. Data broken down for each year as above.
- 3. Please tell me how many of these reported rapes resulted in a conviction. Data broken down for each year as above.
- 4. Please tell me how many of these reported rapes resulted in a dismissal. Data broken down for each year as above."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOI Act).

I can advise you that following a search of our records, I have established that some of the information you requested is held by the Ministry of Defence (MOD). The total number of reported rapes dealt with by the Service Police from 2012 to 2016 are outlined in the table below.

Cases reported to the Service Police from 2012 to 2016

However, under Section 21 of FOIA the MOD is not obliged to supply information that is reasonably accessible to the applicant by other means. If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance Team, Ground Floor, Zone D, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the FOI Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
