Thank you for your email of 1 February 2018 requesting the following information:

“Current list of subcontractors, suppliers and consultants (Project directory) with their company telephone numbers involved in the redevelopment of the surplus military land at Aldershot Garrison to form the Aldershot Urban Extension project. -3,850 new homes; -Refurbishment of 6 listed buildings including 4th Div Head Quarters and the Cambridge Military Hospital as well as a number of local listed buildings; -A new heritage trail; -2 new primary schools; -Day care facilities/nursery of 330 sqm; -A local centre with offices of 3,180 sqm, and local shops of 1,560 sqm and a supermarket of 1,400 sqm; -Pub/restaurant of 610 sqm; -Community and leisure facilities; - Household waste recycling centre; -Approx. 2.4ha of employment area; -110ha of SANGS (Suitable Alternative Natural Green Space); -New play areas and a local park; -Allotments Public access to sports fields. The scheme will include associated car parking, infrastructure, access road, sewer system, enabling works and landscaping.
