Thank you for your email of 30 January 2018 requesting the following information:

*"The detail of the technical repairs required on the Garrison Swimming Pool and the associated quoted costs to repair from different suppliers"*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The pool requires repairs to the failed air extraction and filtration unit. The building and roof have also been damaged by water entering the building via the pipe work in the roof. Below are the costs quoted by the Garrison's maintenance suppliers for the technical repairs required to the pool;

Repair Required	Estimate
Repair of existing ventilation equipment. The higher estimate reflects the possibility that the entire ventilation and cooling system may require replacing.	£25,000 - £50,000
Roof repair. The higher estimate reflects the possibility that the roof might require further structural work and scaffolding, depending on the extent of corrosion of steel supports in the structure.	£8,000-£40,000
Refurbishment and repair of changing rooms	£15,000

Project management costs	£12,000
Refurbishment and asbestos intrusive survey	£1,750
