**The Rural Development (Rules and Decisions) (Amendment)
(EU Exit) Regulations 2018**

The Secretary of State makes these Regulations in exercise of the powers conferred by section 8(1) and paragraph 21 of Schedule 7 to the European Union (Withdrawal) Act 2018(a).

The requirements of paragraph 3(2) of Schedule 7 to that Act (relating to the appropriate Parliamentary procedure for these Regulations) have been satisfied.

Citation and commencement

1. These Regulations may be cited as the Rural Development (Rules and Decisions) (Amendment) (EU Exit) Regulations 2018 and come into force on exit day.
