Authorized Amendment

Summary/Overview of the amendment to explain/ensure that the reader understands: the rationale for the amendment; the major changes; and, importantly, the full context (including desired outcome) of the amendment.

The Regulated Community is reminded to check this amendment against any applicable AAMC, Waivers or Exemptions to ensure their ongoing validity.

The Accountable Manager (Continuing Airworthiness) (AM(CAw)) was introduced at Issue 2 of RA 1016 – Continuing Airworthiness Responsibilities, after which a significant number of Requests for Change (RFC) were received highlighting the complications a directed and Regulated CAw post holder had generated for Defence Contractor Flying Organizations (DCFO). Twelve months after its release a Post Implementation Review meeting was conducted which involved c10 industry partners. A number of actions were agreed at this meeting, one of which was to remove the AM(CAw) role from the Regulation, which was later agreed at subsequent Continuing Airworthiness Advisory Group meetings. Consequently, the AM(CAw) role has been deemed a non-Regulatory requirement and therefore removed from Issue 3 of RA 1016 – Military Continuing Airworthiness Management.

The removal of the AM(CAw) from RA 1016 has impacted a number of other MRP Part M Regulations which referred to the role within either their Regulation, Acceptable Means of Compliance or Guidance Material. To rectify this the following Regulations have been amended to reflect the change:

- RA 4943 Continuing Airworthiness Management Exposition MRP Part M Sub Part G.
- RA 4945 Personnel Requirements MRP Part M Sub Part G.
- RA 4951 Quality System MRP Part M Sub Part G.
- RA 4956 Military Continuing Airworthiness Management Organization Tasks Performed by Other Organizations MRP Part M Sub Part G.

Additionally, the requirement for DCFOs to produce Military Airworthiness Review Certificates for their Military Registered Air Systems has introduced new Regulation for Accountable Managers (Military Flying) which is now reflected in changes to the following Regulations:

- RA 4970 Baseline Military Airworthiness Review MRP Part M Sub Part I.
- RA 4971 Military Airworthiness Review and Certification MRP Part M Sub Part I.

Finally, the MAA intends to commence a full and comprehensive review of the full suite of MRP Part M Regulations in 2019, which will capture all other outstanding RFCs, however, it should be noted that this Notice of Authorized Amendment has included changes to a number of previously identified grammatical, coherency and typographic errors.
