Dear

Thank you for your email received by the Ministry of Defence on 1st August 2018 requesting the following information:

"The number of military personnel recruited to the British Military across the United Kingdom for the past 5 years. I would like the data broken down by: the location, age, gender/race data broken out by year and Service (Army, Royal Navy, Royal Air Force)."

We are treating your correspondence as a request for recorded information under the Freedom of Information Act 2000 (FOIA).

We have completed a search for the information you requested on behalf of the Department and I can confirm that all information in scope of your request is held. However, the statistical information you requested on ethnicity, age and gender is already in the public domain and is therefore exempted from release under the exemption at section 21 of the Act (reasonably accessible to the applicant by other means).

The number of Intakes to UK Regular Forces by age, gender and ethnicity broken by year and service can be obtained from the bi-annual Diversity Statistics publication. Please find the link below:

The number of military personnel recruited by location can be found attached in the corresponding Excel file. As each of the Services record their personnel data differently, their methods of extraction will differ. Army and RAF have provided their data by postcode area up to financial year 16/17 and 17/18 respectively. Royal Navy/Royal Marines have provided their data by career office and region up to financial year 16/17. These figures have been rounded to the nearest 10. To limit disclosure and ensure confidentiality numbers of fewer than or equal to 5 are represented by '~'. Numbers ending in a "5" have been rounded to the nearest multiple of 20 to prevent the systematic bias caused by always rounding numbers upwards.
