

REQUEST FOR INFORMATION - INFORMATION RELATING TO THE MURDER OF ADRIAN CARROLL ON 8 NOVEMBER 1983

I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI(A)), and the process is now complete.

You asked for the following:

"please forward any documentation, minutes, references held by MOD in relation to the murder of Adrian Carroll and the arrest, charge, or discharge of any UDR personnel involved with the case."

Despite an extensive search I have been unable to locate any information regarding the discharge of any UDR Personnel involved in the case, however, I can confirm that the MOD holds some information relating to the murder of Adrian Carroll. This information has been located in a range of documents which I have provided relevant extracts at Annex A. These would have been highly redacted as the remaining information they include is outside the scope of your request. If you wish to receive the documents in the redacted format we can provide on request.

All Police Service of Northern Ireland (PSNI) cases remain open and if new evidence comes forward the PSNI will reinvestigate. Release of these documents must be carefully considered under Section 31 (Law Enforcement) of the FOI(A). I have completed this consideration through a public interest test including consultation with the PSNI who have advised that release of some of the information could adversely impact on any investigative process, and may jeopardise any future prosecutorial process. On this basis I am withholding some of the information under Section 31 of the FOI(A).

I appreciate that this incident took place 35 years ago and the passage of time can be a factor in diminishing the applicability of exemptions to information. However, in this instance the passage of time is less relevant as the PSNI continue to investigate Troubles-related murders and the overall balance is in favour of partial exemption.

In addition, some of the information falls within the scope of Section 38 (Health and Safety) of the FOI(A), as its release could endanger the physical or mental health of any individual, or endanger the safety of any individual.

Section 38 is a qualified exemption and we have conducted a public interest test to determine whether the information should be released or withheld. The factors for this public interest have determined that whilst disclosure would demonstrate openness and transparency this is outweighed by the detrimental effect disclosure could have on those mentioned in the documents,

or their family members and friends. I have concluded that whilst disclosure may be of historical interest, the health and safety of individuals must be taken into account especially where release would be likely to endanger, the physical or mental health of any individual. Some information has therefore been redacted under Section 38 of the FOI(A).

Some of the information contained within the disclosure constitutes personal information, such as names and addresses. Under FOIA 2000 this information is exempt under Section 40 (2) by reason of the first condition under Section 40 (3) (a) (i), as disclosure would contravene data protection principles under the Data Protection Act 1998 (DPA 98). This is an absolute exemption and does not require a public interest test to be conducted in order for this information to be exempt from disclosure. Therefore all information has been redacted.

Comment

At approximately 1635 hrs the IP was walking home from his work. [Redacted] He was about 10 yds from his door [Redacted]. In the FU one [redacted] bullet was found [Redacted]. The remaining [Redacted] bullets [Redacted] could not be located. At [Redacted] a coded message was received by Downtown Radio purporting to have come from the Protestant Action Force claiming responsibility for the shooting.

Cases in the Pipeline

6. As well as the above there are several major cases where UDR soldiers have been charged with serious crimes and are still awaiting trial. In particular:

a. five soldiers of 2 UDR are charged with the murder of Adrian Carroll, and one soldier with aiding them. This was the crime-allegedly committed whilst on patrol – which lead to the complaints about the Duke of Edinburgh's visit to Drummard Barracks, Armagh in February 1984.
