- 1, Please could you provide the number of RAF Airmen and Officers who were subject to drug testing from 1 Jan 2014 present.
 - (a) Of those, how many tests indicated an Airman or Officer had misused drugs or substances?
 - (b) If possible, please could you provide further information as to which drugs were found in these tests?
 - (c) Of those who tested positive for misuse of drugs and substances and the investigation has been concluded were discharged as a result?
- 2, If RAF Reserves and Auxiliary personnel were not included in question 1, please could you provide the number of reservists and auxiliary personnel who were subject to drug testing from 1 Jan 2014 present.
 - (a) Of those, how many tests indicated an Airman or Officer had misused drugs or substances?
 - (b) If possible, please could you provide further information as to which drugs were found in these tests?
 - (c) Of those who tested positive for misuse of drugs and substances and the investigation has been concluded were discharged as a result?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held.

The information you have requested can be found in the table below and does include RAF Reserves and Auxiliary personnel:

The drugs identified in these tests include cannabis, ecstasy, cocaine, benzodiazepines, steroids and norketamine.

Drug use is incompatible with military service and personnel are subject to random compulsory drug testing. This has always been our policy and, except in exceptional circumstances, personnel caught taking drugs can expect to be discharged.

The MOD conducts compulsory drug tests because substance misuse is incompatible with Service life and anyone who falls short of our high standards can expect to be disciplined. In a very small number of exceptional circumstances, second chances may be considered. This only happens where a Commanding Officer believes the individual meets the stipulated retention criteria. These are laid out in Joint Service Publication (JSP) 835 which also details the MOD's process for dealing with a positive CDT result. JSP 835 is available on the gov.uk website:

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that some individuals may test positive for multiple drugs or have more than 1 positive drug test.
