JUDGMENT

The judgment of the Tribunal is that:

1. All of the claims which were struck out in August 2017 and confirmed as such on 7 December 2017 in a previous Judgment are reinstated and all those claimants can now pursue their claims for unlawful deduction of wages.
2. The claimants' solicitors, however, shall pay to the respondent's solicitors the sum of £3,910 plus VAT at 20% on the basis that there has been wasted costs for the respondent with regard to the way in which the claimants' solicitors dealt with this matter.
3. The application for costs by the claimants' solicitors against the respondent with regard to the costs of today is refused and dismissed.
