## Notice of Mortgage Intent

### GUIDANCE NOTES – PLEASE READ

- If more than one mortgagor (borrower) then a separate form is required, unless shares are owned jointly.
- If more than one mortgage is submitted at the same time the mortgagees will be required to advise which mortgage to register first in a signed letter on headed paper.
- The notice of mortgage intent is recorded on the Register for a period of 30 days, unless it is withdrawn during this time.
- The notice may be renewed or further renewed for a period of 30 days, by notice in writing to the Registry. The relevant fee is required each time.
- Section 1 must be completed if the vessel is already registered in the UK.
- Section 2 must be completed if the vessel is not currently registered in the UK.
- Sections 3 and 4 must be completed in all cases.
