Thank you for your email of 10 August 2018 requesting the following information:

- "1. Over a twelve-month period, up to and including July 2018, how many applicants for civilian civil service posts advertised in MoD applied through the guaranteed interview scheme (for disabled applicants)? Please could the answer be broken down into external applicants and internal applicants and given as an overarching total and the statistics also broken down into grade applied for?
- 2. Of those who applied through the guarantee interview scheme as outlined in point 1, how many were then offered an interview? Again, could the answer be broken down into external applicants and internal applicants and given as an overarching total and the statistics also broken down into the grade applied for?
- 3. Of those who applied under the guarantee interview scheme as outlined in point 1, how many were then offered the post applied for (or an equivalent post via a reserve list)? Again, could the answer be broken down into external applicants and internal applicants and given as an overarching total and the statistics also broken down into the grade applied for?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

Annex A provides the answers to each of your questions. The data is based on applications for MOD or Defence Equipment and Support (DE&S) vacancies between August 2017 and July 2018. The information has also been separated into three categories; Internal Applicants, External Applicants and those applying from Other Government Departments.

Under Section 16 (Advice and Assistance) you may wish to be aware that candidates with declared disabilities will be offered a guaranteed interview provided they meet the minimum essential criteria for the post being advertised. Further information about the

scheme can be found within the Department's Civilian Disability Toolkit. Guidance on the minimum essential criteria, currently scores of 4 for each competency, can be found within the Line Managers' Guidance to Civil Service Jobs (pp.33-34).

You may also wish to know that Civil Service Jobs is a civil service wide recruitment system administered externally by a company called World Careers Network (WCN), under contract to the Cabinet Office. As such the Department only receives limited cuts of data on a weekly basis.

Finally, you should note that the grade structure of DE&S differs from that of the MOD. From 1 April 2017, all DE&S employees moved to a new five-level structure, which is not directly aligned to that of the MOD. This analysis is based on information contained within the data received from CS Jobs, which does not offer a more detailed breakdown of the DE&S-specific grades.
