Redcar & Cleveland Borough Council
Skelton Public Footpath No. 232
Definitive Map and Statement Modification Order 2018

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **18 December 2018**.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **The Redcar Leisure and Community Heart, Ridley Street, Redcar TS10 1TD** on **Tuesday 18 June 2019** at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding to them a public footpath from grid reference NZ 6709 1654 (High Street, Lingdale) in a northerly then westerly then north easterly then north-north easterly direction for approximately 247 metres to grid reference NZ 6718 1674.

Timetable for sending in statements of case and proofs of evidence

Within 8 weeks of the start date by [by 12 February 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting

documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 26 March 2019]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [by 21 May 2019]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents - although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any

supporting documents – although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.

This order is made by Redcar & Cleveland Borough Council ("the Council") under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to the Council that the Definitive Map & Statement for the Borough of Redcar & Cleveland (excluding the North York Moors National Park) requires modification in consequence of an event specified in Section 53(3)(c)(i), namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map & statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to Section 54A, a byway open to all traffic.

The Council has consulted with every local authority whose area includes the land to which the order relates.

The Council for the Borough of Redcar & Cleveland hereby order that:

1. For the purpose of this order the relevant date is 12 March 2018
2. The Definitive Map & Statement for the Borough of Redcar & Cleveland (excluding the North York Moors National Park) shall be modified as described in Part I and Part II of the Order Schedule and as shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the Redcar & Cleveland Borough Council Skelton Public Footpath No.232 Definitive Map & Statement Modification Order 2018.

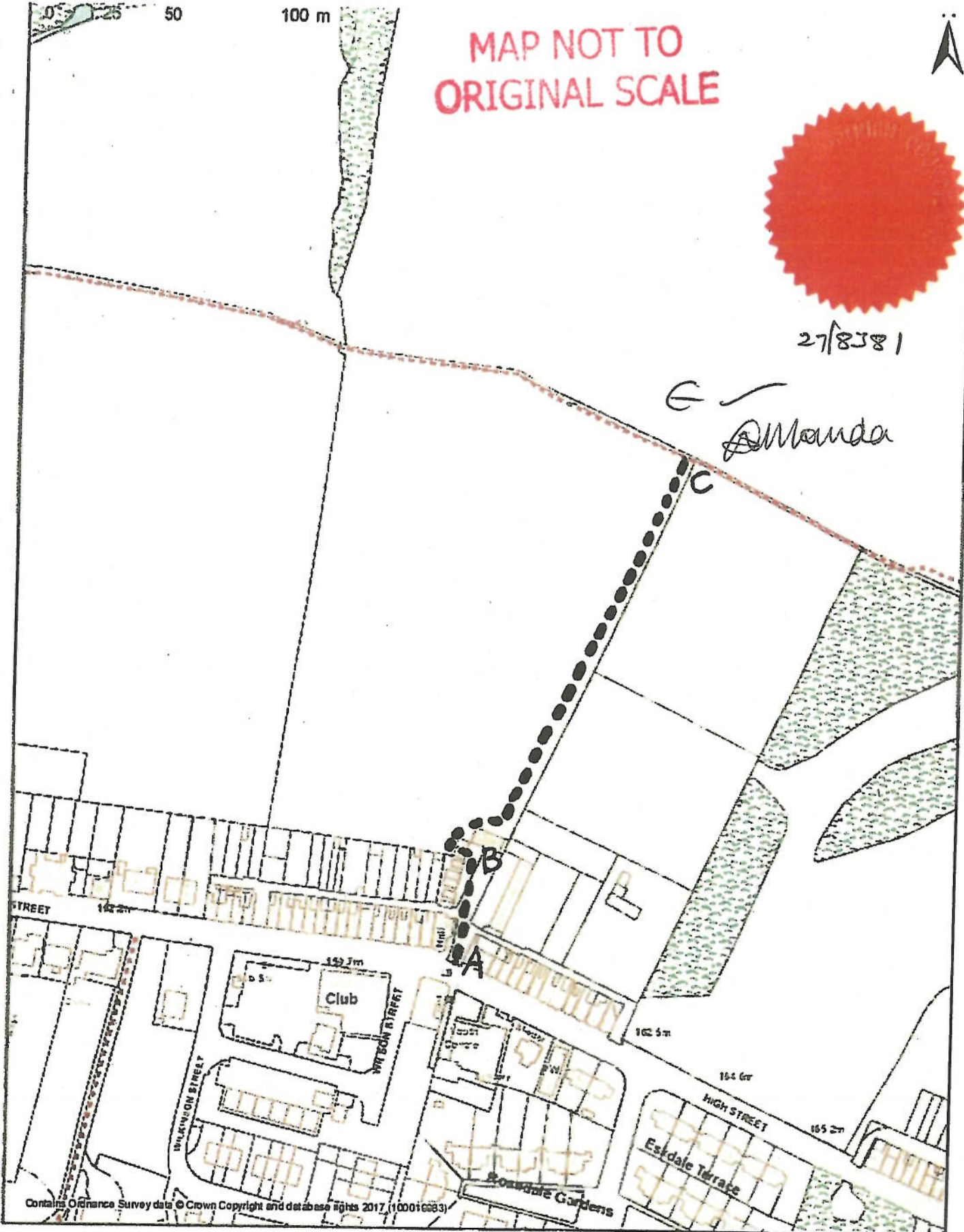
Section of path or way as shown in the order map	Description of the path or way to be added
The footpath to be added to the definitive map is marked on the order map by a bold broken line and shown as: A-B-C	The footpath commences at grid reference NZ6709 1654 (Point A in the Order map) and proceeds in a northerly direction for 45 metres to grid reference NZ6710 1658 (Point B in the Order map) and then continues in a westerly direction for 12 metres then in a generally north-easterly direction for 30 metres and then in a generally north-north- easterly direction for 160 metres to grid reference NZ 6718 1674 (Point C in the Order map). The width of the footpath is 1.0 metres.
