<u>FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE:</u> SCREENED OUT CRIMES

I refer to your e-mail dated 29 August 2018, which was acknowledged on 30 August 2018.

We are treating your e-mail as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your e-mail you requested the following information:

"1. The number of crimes that have been screened 'out' for further investigation or 'filed' shortly after it was reported to the police. These are cases which do not qualify for investigation after an initial screening process. Please provide this information for the calendar years 2014-17, and to date (May 25th) for 2018. Please break this information down into individual offence as per the Count Offence Classification Index, to which I provide a link below. Please also provide the data as broken down by the offence categories eg violence against the person, sexual offences. For the avoidance of doubt, I also require information for Fraud offences.

2. Please can you provide me with the number of crimes reported to your force for the calendar years 2014-17 and to date (May 25th) for 2018. Please break this information down into individual offence as per the Count Offence Classification Index, to which I provide a link above. Please also provide the data as broken down by the offence categories eg violence against the person, sexual offences. For the avoidance of doubt, I also require information for Fraud offences."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

"1. The number of crimes that have been screened 'out' for further investigation or 'filed' shortly after it was reported to the police. These are cases which do not qualify for investigation after an initial screening process. Please provide this information for the calendar years 2014-17, and to date (May 25th) for 2018. Please break this information down into individual offence as per the Count Offence Classification Index, to which I provide a link below. Please also provide the data as broken down by the offence categories eg violence against the person, sexual offences. For the avoidance of doubt, I also require information for Fraud offences."

The Ministry of Defence Police (MDP) does not have a specific crime screening process. If crimes are reported to the MDP that are not within our remit they are passed to the local Home Office Police force or Police Scotland accordlingly. These crimes are not recorded on our systems. Therefore, all crimes recorded are crimes the MDP have dealt with.

"2. Please can you provide me with the number of crimes reported to your force for the calendar years 2014-17 and to date (May 25th) for 2018. Please break this information down into individual offence as per the Count Offence Classification Index, to which I provide a link above. Please also provide the data as broken down by the offence categories eg violence against the person, sexual offences. For the avoidance of doubt, I also require information for Fraud offences."
