<u>FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE:</u> DISCIPLINES FOR RACIST VIEWS

I refer to your e-mail dated 06 September 2018, which was acknowledged on 11 September 2018.

We are treating your e-mail as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your e-mail you requested the following information:

- "1. The number of police officers disciplined due to expressing views of a racial or racist nature- either verbally, in written form, online or on social media in each of the financial years (April to March) 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18.
- 2. The number of civilian staff disciplined due to expressing views of a racial or racist nature either verbally, in written form, online or on social media in each of the financial years (April to March) 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18.
- 3. Please break down the answers to questions 1 and 2 into outcomes of disciplinary action, specifically: how many resulted in no further action, how many in proceedings being discontinued/not proven, how many ended in management advice, how many with a verbal warning, how many with a written warning and how many in a final written warning and how many in dismissal?

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.
