Thank you for your email of 29 March 2018 requesting the following information:

"My understanding is that the road in question, in your response referred to as "Hospital Road" was split in two and sold to two separate owners. One of whom purchased their area of road without a hangar, the other purchased their area of road as part of the sale of a hangar. Please could I confirm that the information you have provided relates to the sale of the portion of road sold with a hangar?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found enclosed at Annex A, which is the map from the original sale. The entirety of Hospital Road was sold by Secretary of State for Defence to Dukeminster Ltd on 14 January 2000.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that Hospital Road has since been sold by Dukeminster Ltd to two different parties and the responsibility for Hospital Road now sits with the new owners.

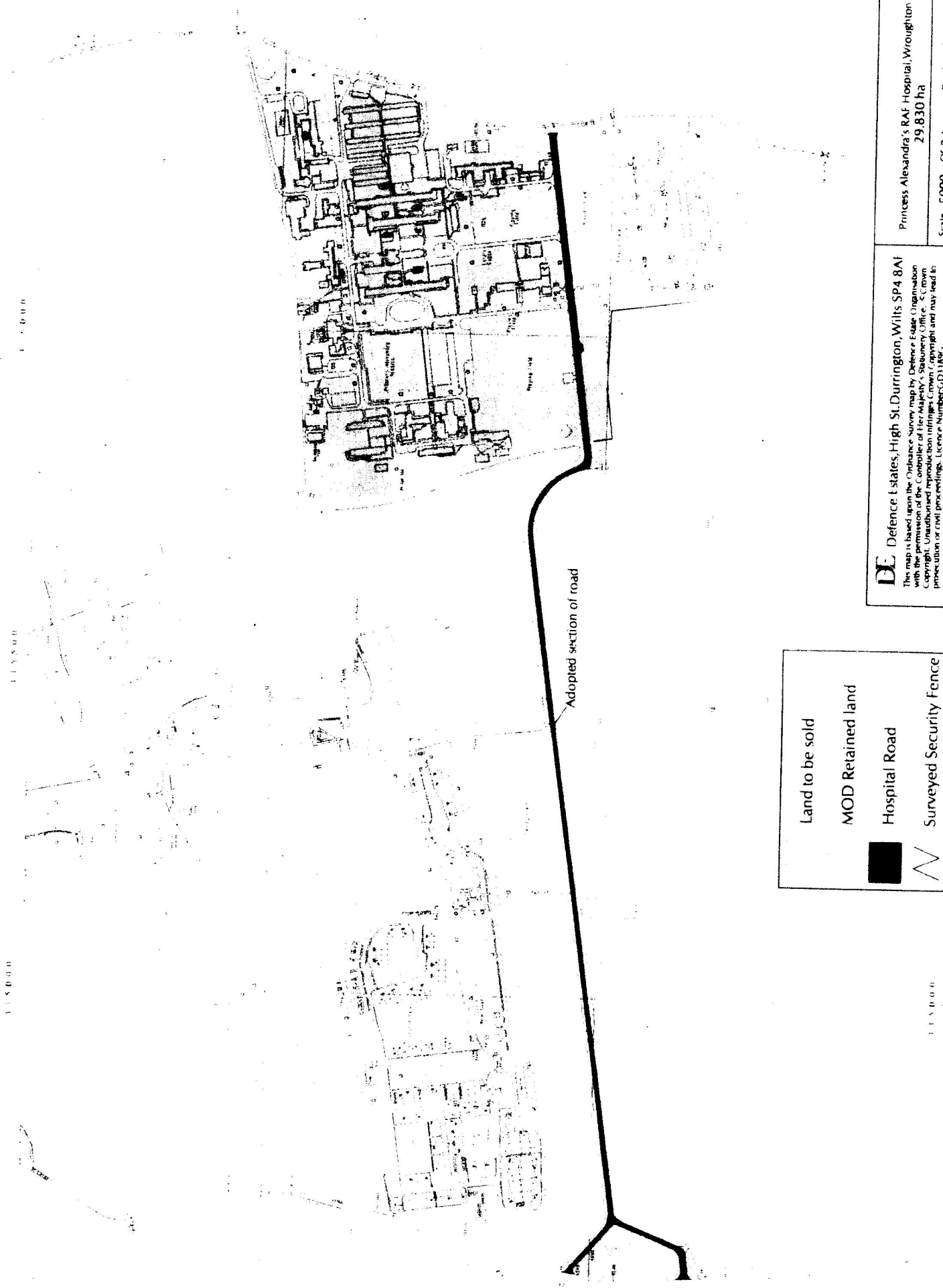
