We are treating your e-mail as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your e-mail you requested the following information:

5. The outcome. For example, no action taken verbal warning, written warning, resigned etc."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

Please note that the policy of the Ministry of Defence Police is to record all potential misconduct matters centrally. As such, the majority of the information shown on the attached table relates to alleged minor breaches of discipline. The majority of the misconduct matters recorded by the Force during the period covered by your request did not constitute Gross Misconduct and did not require a misconduct hearing.
