Thank you for your email received by the department on 30 September 2018 requesting the following information:

"Under the " Freedom of Information Act " i would like to know.

Those Soldiers that served in the 1ST Gulf War, that have since died of Cancers. Could this be shown in what Regiments/Corps they served in?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held.

As at 31 December 2015 (the latest data available) there were **501** UK veterans of the 1990/91 Gulf Conflict that have since died from cancer. **Table 1** presents this information by Service and Corps at the time of Gulf 1. Corps is an Army specific category and was not recorded on the Gulf 1 cohort data for Naval Service and RAF personnel. Therefore, the summary by Corps has only been provided for Army personnel.

Please note that it is not possible to attribute these deaths due to cancer with previous deployment on the Gulf 1 conflict.

Following advice from Defence Statistics' Army manpower branch, Army Infantry Corps have been presented by Division. Please note that these groupings differ to historic figures you have received following previous FOI requests.

Under Section 16 (advice and assistance) you may wish to note the following:

The Gulf 1 mortality study compares the mortality rates of 53,409 UK Armed Forces personnel that deployed to the 1990/91 Gulf Conflict to those of a comparison group, the Era cohort. The Era cohort consists of 53,143 UK Armed Forces personnel of similar age, gender, Service, regular/reservist status and rank who were in Service on 1 January 1991 but did not deploy to the Gulf. The findings include deaths that occurred to personnel whilst in service and deaths that occurred after personnel had left the UK Armed Forces.

Please note that during production of the latest published Gulf 1 mortality statistics, Defence Statistics identified possible inaccuracies between NHS Digital deaths data and the cause of death data held by the MOD. Therefore, all figures presented by cause of death within the latest release

^{3.} Long Service List – service in one of the appointments not specified to a particular arm which have been annotated by the Ministry of Defence as being suitable for the extra-regimental employment of soldiers who have completed 22 years reckonable service. Please note this engagement existed at the time of Gulf 1 but is not a current engagement within the Army.

^{4.} Staff – all personnel at the rank of Colonel or above are listed as Staff.
