The Regulatory Policy Committee (RPC) is content that, on the basis of the summary information provided, none of the measures or activities covered in the summary document should be considered as a qualifying regulatory provision for the purposes of the business impact target. This statement does not provide a detailed view of any specific activity in the regulator's summary document. Nor does it comment on any activities not included in the summary. Some activities might, however, have been the subject of separate assessments of qualifying regulatory provisions.

Comments on the non-qualifying regulatory provision summary

The regulator has provided an adequate description. It would have been helpful if the assessment gave some information to support their assertion that these items are *de minimis*, such as a description of impacts.


The regulator has included a number of measures against the 'monopoly providers (or those with significant market power)' exclusion. The RPC notes that this exclusion is not included, at least in this form, in the exclusions listed for the framework for the current parliament, as announced on 20 June 2018. The RPC notes, however, that the regulator has stated that the measures are, in any case, under the *de minimis*, and therefore non-qualifying.

The regulator has helpfully, at Appendix 1, identified the exclusion categories from the 2015-17 BIT framework to which the measures would apply if those categories applied to the current BIT reporting period. The RPC welcomes the clarity and transparency this additional material provides.
