# 1. Introduction

The 2014 to 2020 European Structural and Investment Funds bring the European Regional Development Fund, European Social Fund and part of the European Agricultural Fund for Rural Development together into a single European Union Structural and Investment Funds Growth Programme for England supporting the key growth priorities of innovation, research and development, support for Small and Medium Sized Enterprises, low carbon, skills, employment, and social inclusion.

The Government has confirmed that it will guarantee funding for ERDF projects that are contracted by the end of 2020.

All contracted ERDF projects must be completed by the end of the programme period, 31 December 2023. Each application for ERDF will be required to demonstrate that it delivers good value for money and domestic strategic priorities.

The funds are managed by the Ministry of Housing, Communities and Local Government for the European Regional Development Fund, Department for Work and Pensions for the European Social Fund and the Department for Environment, Food and Rural Affairs for the European Agricultural Fund for Rural Development. These Departments are the managing authorities for each Fund. In London, the Greater London Authority acts as an intermediate body for the European Regional Development Fund and European Social Fund programmes. In some other areas, Intermediate Bodies are being designated by the Ministry of Housing, Communities and Local Government and the Department for Work and Pensions to perform the following tasks:

1. Input into project calls in respect of local development needs (with reference to ESI Funds Strategies); and
2. Assessment of applications against certain selection criteria in relation to fit with local priorities in respect of the European Regional Development Fund and European Social Fund.

The managing authorities and intermediate bodies work closely with local partners on ESI Funds sub-committees in each local enterprise partnership area. Partners on these sub-committees provide:

1. Practical advice and information to the managing authorities to assist in the preparation of local plans that contribute towards operational programme priorities and targets;
2. Local intelligence to the Managing authorities (or intermediate bodies where designated) in the development of project calls that reflect operational programme and local development needs as well as match funding opportunities; and

3. Advice on local economic growth conditions and opportunities within the context of the operational programme and the local European Structural and Investment Funds strategy to aid the Managing authorities' (or intermediate bodies where designated) assessments at outline and full application stage.

This call is issued by the Ministry of Housing, Communities and Local Government and invites outline applications in respect of the European Regional Development Fund for England 2014 to 2020.

## 2. Call Context

On behalf of the national Growth Programme Board, the Ministry of Housing, Communities and Local Government (the managing authority) invites applications seeking European Regional Development Fund support under:

### **Priority Axis 2    Enhancing Access To, and Use and Quality of, Information and Communications Technology**

#### **Investment Priorities:**

- 2a**        Extending broadband deployment and the roll-out of high-speed networks and supporting the adoption of emerging technologies and networks for the digital economy
  
- 2b**        Developing Information and Communications Technology products and services, e-commerce, and enhancing demand for Information and Communications Technology

The **European Regional Development Fund Operational Programme for England 2014 to 2020** sets out how the European Regional Development Fund will focus on investment to support economic growth and job creation. **Priority Axis 2** of the operational programme aims to enhance access to, and use and quality of, information and communications technology.

Any application for funding will be required to clearly demonstrate that it provides good value for money and supports domestic strategic priorities, including the 2017 [Industrial Strategy](#) (or any later publication that amends or supersedes that). Applications must meet the requirement of, and make a meaningful contribution to, the delivery of the relevant Priority Axis of the [European Regional Development Fund Operational Programme](#) and where appropriate should reflect how such support will aim to improve productivity levels within small and medium sized enterprises.

In addition, applications will be expected to meet identified local development needs, as expressed in the scope of this call and as set out in the Cornwall and Isles of Scilly [local enterprise partnership area European](#) Integrated Territorial Investment strategy.

Applicants are advised to familiarise themselves with the detail of the operational programme, local European Structural and Investment Funds strategy and the relevant documentation listed in sections 5 through to 8 **prior to** submitting an outline application.

### 3. Scope of the Call

#### 1. Scope

This call invites outline applications which support the delivery of Priority Axis 2 of the European Regional Development Fund operational programme and respond to the local development need set out in the Cornwall and Isles of Scilly [local enterprise partnership area](#) Integrated Territorial Investment strategy.

<p><b>Indicative fund allocation:</b></p>	<p>Indicatively, through this call the managing authority expects to allocate up to £4,200,000.</p> <p>The managing authority reserves the right to invite to full application (and subsequently approve) projects that have a cumulative value that is higher or lower than this indicative allocation, subject to the volume and quality of proposals received. The managing authority may also decide to place some projects submitted through this call on a reserve list and invite them to proceed at a later date, subject to the availability of funding.</p> <p>There is no indicative allocation of European Regional Development Fund funding between capital and revenue activity, both capital and revenue is eligible dependent on the nature of activities/Investment Priorities set out in the call.</p>
<p><b>Minimum application level</b></p>	<p>European Regional Development Fund investment is intended to make a significant impact on local growth. Applications are expected to demonstrate appropriate scale and impact. The managing authority does not intend to allocate less than £500,000 European Regional Development Fund to any single project. Consequently projects with a total value of less than £625,000 will not normally be supported under this call</p>
<p><b>Duration of project activity</b></p>	<p>Projects should plan to deliver activity for a maximum of three years; however the managing authority reserves the right to vary the maximum duration, upwards or downwards.</p>

<p><b>Geographical scope</b></p>	<p>The England European Regional Development Fund operational programme operates on a national basis. All eligible European Regional Development Fund expenditure must benefit organisations located in England.</p> <p>Revenue projects should predominantly support businesses based within the local enterprise partnership area of this call.</p>
<p><b>Specific call requirements</b></p>	<p>As a Less Developed Region the intervention rate available in Cornwall and the Isles of Scilly may be up to 80% subject to compliance with State Aid law.</p> <p>Applicants will need to have eligible match funding for the balance of costs which must be from a source other than the European Union. Applicants are responsible for identifying the match funding required to complete the funding package. This can include a contribution towards the costs of the provision provided through the project from the businesses themselves.</p> <p>The Commission makes a distinction between areas where no broadband infrastructure exists or is unlikely to be developed in the near term (white areas), areas where only one broadband network operator is present (grey areas) and areas where at least two or more broadband network providers are present (black areas). European Regional Development Fund investment must contribute to the delivery of superfast broadband in white areas.</p> <p>Activities must address market failure. European Regional Development Fund can only be used to achieve additional activity or bring forward activity more quickly, and Applicants must be able to demonstrate that what they are proposing is additional to what would have occurred anyway. European Regional Development Fund investment is therefore limited to the minimum amount required to ensure the operation can proceed.</p> <p>Applications should demonstrate demarcation with initiatives funded through the European Agricultural Fund for Rural Development.</p> <p>All procurement must be undertaken in line with European Union regulations.</p> <p>Applicants must demonstrate compliance with state aid law.</p>

	<p>The investment can either be made in a single proposal that will deliver all the activity envisaged under this call or through multiple awards.</p> <p>Projects should be capable of providing coverage for the whole of the Local Enterprise Partnership area including the very rural parts of Cornwall and the Isles of Scilly.</p> <p>Applications are welcome from a single organisation or a consortium (with an identified lead applicant) in line with European Regional Development Fund Eligibility Rules Guidance.</p> <p><b>Please note: Value for Money and alignment with Strategic Domestic Priorities , <a href="#">including the 2017 Industrial Strategy</a></b>, (or any later publication that amends or supersedes that). will form a key part of the assessment and appraisal of all applications. Therefore proposals should clearly articulate and demonstrate how activities align with domestic strategic priorities and offer good value for money.</p>
<b>Call deadlines</b>	<p>For this specific call, applications will be assessed after the close of the single deadline.</p> <p>Applications received after the published call close date will not be considered. All applications will be assessed following closure of the call.</p>

## 2. Local development need

Projects must deliver activity which directly contributes to the objectives of Priority Axis 2 of the operational programme, one or more of the relevant Investment Priorities and meet the local development need expressed in the table below.

<b>Local Development Need</b>
<p><b>Local growth priorities:</b></p> <p>One of the strategic objectives within the ‘Conditions for Growth’ strand of the Cornwall and the Isles of Scilly Local Enterprise Partnership European Integrated Territorial Investment Funds Strategy is ‘To invest in digital infrastructure and digital skills for growth’.</p> <p>The Cornwall and the Isles of Scilly Local Enterprise Partnership recognises the opportunities that competitive digital infrastructure can play in helping to address</p>

the problems of peripherality, which remains a continuing constraint for Cornwall and the Isles of Scilly. The physical distance from national and international markets is seen as a key issue prohibiting businesses from growing and accessing new markets. Improved digital infrastructure will contribute to supporting the growth, sustainability, innovation culture and global competitiveness of high value economic activity.

Cornwall is geographically peripheral and predominantly rural in nature. There are a number of key towns but the population and business base is widely dispersed, with some areas relatively remote from both public transport and main road links. The Isles of Scilly lie 28 miles off Land's End and are comprised of an archipelago of small islands, five of which are inhabited. Transport links by sea and air are reduced in the winter months, and are often subject to disruption due to adverse weather conditions. Applicants are therefore encouraged to demonstrate how activity will be delivered across all the geographic areas, including and with specific reference to those areas which are difficult to reach.

Through the 2007-2013 Convergence Programme, over £50m of European Regional Development Funding was invested in rolling out superfast broadband infrastructure across Cornwall and the Isles of Scilly. This resulted in the region having one of the best rural networks anywhere in the world, with 95% of properties within the region having access to fibre-optic broadband by the end of June 2015, including 83% at 30+Mbps superfast speeds. A further phase of activity delivered through the Government's Broadband Delivery United Kingdom Superfast Extension Programme between 2015-2017 increased this coverage by an additional 10,000 premises. At the end of 2017 it was estimated that 86% of premises were able to access superfast broadband of 30+Mbps, of which 31% had access to ultrafast broadband of 100+Mbps. European Regional Development Fund investment already committed through the 2014-2020 Growth Programme will upgrade a further 7,500 premises with access to 30+ Mbps broadband, including 1,200 Small and Medium Sized Enterprises. Take up of superfast broadband infrastructure remains at one of the highest levels in the country.

Despite this progress, peripherality remains a continuing constraint for Cornwall and the Isles of Scilly, with the physical distance from national and international markets seen as a key issue prohibiting businesses from growing and accessing new markets. The significant investment made during the Convergence programme in broadband infrastructure has helped address this issue but the problem has not gone away completely. This is in part because, although take up of broadband has been high, many businesses have been slow to recognise the competitive advantage that using Superfast can bring. Whilst they are aware they can access faster broadband speeds, businesses do not always understand what can be achieved from using them. Consequently, businesses need to be supported in understanding how these new and emerging technologies can be fully applied and exploited and encouraged to understand how Information and Communications Technology can increase business performance and access new markets.



### **Local priorities:**

Proposals should demonstrate alignment with local development need and priorities including:

- Applicants wishing to extend broadband infrastructure will need to demonstrate how they will ensure investment is only targeted in extending coverage of superfast broadband in areas that do not currently have access to 30+Mbps broadband (also known as Next Generation Access White areas);
- Projects that enhance connectivity via fixed, mobile or wireless devices;
- Targeting delivery, where appropriate, at clusters of businesses, for example business parks, innovation centres and Enterprise Zones;
- Increasing the number of Small and Medium Sized Enterprises making productive use of digital technologies with a focus on Cornwall and the Isles of Scilly's priority and high growth sectors, to support increases in productivity;
- Demonstrate local market failure and the need for public intervention;
- Activities focused on new and emerging technologies to ensure they are used to optimum levels to improve Small and Medium Sized Enterprises productivity, increase Small and Medium Sized Enterprises digital capability and capacity to grow and innovate;
- Proposals should consider the provision of specialist business and innovation support related to the application of information and communication technology to company growth;
- Any proposed technology solution should be an appropriate solution taking into account the economic and geographic characteristics of Cornwall and the Isles of Scilly;
- Support to Small and Medium Enterprises in updating or introducing new Information and Communication Technology business models which will drive business performance this may be through providing coaching, advice, consultancy, mentoring and support to access new markets through improved Information and Communication Technology connections and skills strategies;

- Demonstration and pilot projects, showcasing how Small and Medium Sized Enterprises can stimulate innovation through the smart use of Information and Communications Technology and access to high speed networks, including the dissemination of the results;
- Applicants should explain how they will work in close partnership with the Cornwall and Isles of Scilly Growth Hub and Skills Hub. This would include working with the navigators in the Growth Hub to offer a joined-up service for the businesses as well as sharing information between projects with regular communication;
- Applicants should explain how they will deliver a programme of activity that encourages businesses to be ambitious, thereby delivering broader and longer terms impacts, including higher value job creation;
- Applicants should explain how they will keep abreast of new initiatives coming on stream in Cornwall and the Isles of Scilly as a result of delivery of the European Structural and Investment Fund/Integrated Territorial Investment Strategy and explain, where appropriate, how links will be developed;
- Applicants are strongly encouraged to exceed the cross cutting theme requirements detailed in the operational programme. The Integrated Territorial Investment Board will seek to provide its support to projects that demonstrate how the application will embed the cross cutting themes good and best practices into the proposed project's activities through the [Inclusion Strategy](#) and the [Environmental Growth Strategy](#) and as outlined in the [Cornwall and Isles of Scilly Integrated Territorial Investment Strategy](#). In addition, the principles of inclusion and sustainable environmental growth need to be articulated with specific reference to the Isles of Scilly;
- Applicants are encouraged to explain how they will work closely with the European Social Fund skills provision and the national skills provision to support an increase in higher level skills to underpin economic growth.

Any potential applicants wishing to apply for funding under this call can make use of the Access to the Programme Team. This free resource will provide advice and support to potential applicants; offer specialist support in the early stage design and development of complex projects; and promote and integrate the cross cutting themes within projects to ensure that applicants can develop projects that make the most effective use of all European Structural and Investment Funds. ### 3. Operational programme investment priorities

Applications must specify the activities to be delivered and must directly contribute to one or more of the following investment priorities:

<b>Investment priority</b>	<b>2a – Extending broadband deployment and the roll-out of high-speed networks and supporting the adoption of emerging technologies and networks for the digital economy.</b>
<b>Specific objectives</b>	Increase the coverage of superfast and ultrafast Broadband in areas where the market is failing, particularly where this is creating a barrier to small and medium sized enterprise growth.
<b>Indicative actions</b>	<p>Projects will support the extension of coverage of superfast (capable of delivering speeds of more than 30 Mbps) and ultrafast (speeds of more than 100 Mbps) broadband networks. Under this investment priority the types of actions that the European Regional Development Fund may support include:</p> <ul style="list-style-type: none"> <li>• Providing financial support for projects to extend availability of superfast broadband networks</li> <li>• Providing financial support for projects to provide availability of ultrafast broadband networks.</li> </ul>

<b>Investment priority</b>	<b>2b – Developing Information and Communications Technology products and services, e-commerce, and enhancing demand for Information and Communications Technology.</b>
<b>Specific objectives</b>	Increase the number of small and medium sized enterprises making productive use of digital technologies.

**Indicative actions**

The support provided through this specific objective will help small and medium sized enterprises to be able to understand and use information and communication technology products and services appropriate for their business. It will complement action under the other investment priority in this axis as well as action under priority axes 1 and 3:

Under this investment priority, actions that the European Regional Development Fund may support include:

- Support for small and medium sized enterprises to update or introduce new information and communication technology business models which will drive business performance;
- Provision of coaching, advice, consultancy, mentoring and support for small and medium sized enterprises to access new markets through improved information and communication technology connections;
- Provision of coaching, advice, consultancy, mentoring and support for to develop information and communication technology skills strategies;
- Provision of coaching, advice, consultancy, mentoring and support to implement productivity improvements from use of information and communication technology;
- Demand-side voucher schemes;
- Demonstration and pilot projects, showcasing how small and medium sized enterprises can stimulate innovation through the smart use of information and communication technology;
- Support for diffusion of results from demonstration and pilot projects; and
- Support for the integration of small and medium sized enterprises in digital supply chains through the smart use of information and communication technology.

Activities will target small and medium sized enterprises, including social enterprises.

## 4. Required Outputs under this Call

Applicants will need to demonstrate how the eligible activity, funded by the European Regional Development Fund will achieve the programme-level outputs for Priority Axis 2.

For projects proposing to deliver activity against more than one investment priority, the appropriate outputs should be selected. Project will be required to report on, and evidence, the achievement of the outputs separately under each investment priority.

For projects coming forward under this call the expected outputs and results are:

The managing authority expects the level of outputs proposed within outline applications to be realistic and achievable and to deliver good value for money. The application should clearly state the methodology used to determine the levels of outputs proposed.

Projects will only be supported if they demonstrate good value for money. An important consideration when assessing value for money is the level of European Regional Development Fund outputs that the project would deliver.

The managing authority has not set specific output targets for this Call and does not publish average or expected unit costs.

The local European Structural and Investment Fund strategy for each local enterprise partnership area includes details of the local, notional European Regional Development Fund allocation to each priority axis and the type and number of European Regional Development Fund outputs that are expected in return for this investment.

All operations will be required to report regularly on progress toward achievement of targets. This will need to include both quantitative and qualitative data relevant to the appropriate geographical areas. Applicants will need to explain how they will collect and record this information to maintain a fully evidenced audit trail. It should be noted that if an operation fails to deliver contracted outputs, a performance penalty may apply.

## 5. Application Process and Prioritisation Methodology

There are two stages to the European Regional Development Fund application process:

1. Outline application and, if successful
2. Full application.

Acceptance of an outline application to progress to full application stage does not in any way indicate or constitute an offer of European Regional Development Fund grant.

Applicants must fully complete the [outline application](#) which will be assessed by the managing authority against all of the national [selection criteria](#) except where an intermediate body has been designated to assess against some of the selection criteria. Where an intermediate body has been designated to undertake delegated tasks, the intermediate body will undertake the assessment against the selection criteria in relation to fit with local priorities.

Outline applications will be assessed in two stages, Gateway assessment and Core assessment.

The Gateway assessment is undertaken by the managing authorities and considers:

- Applicant eligibility;
- Activity and expenditure eligibility; and
- Fit with the National operational programme and the local development need set out in section 2.

Applications that fail the Gateway assessment undertaken by the managing authority will be rejected. Applications which pass the Gateway assessment will then be assessed by the managing authority in relation to all Core assessment criteria.

In areas where an intermediate body<sup>1</sup> has been designated, the following will apply:

The intermediate body will assess the application against the following Core assessment criteria:

- Local strategic fit

The managing authority will assess the application against the following Core assessment criteria:<sup>2</sup>

- National strategic fit;
- Value for money;
- Management and control;
- Deliverability;
- Compliance;
  - Procurement
  - State Aid
  - Publicity requirements
- Cross cutting themes; and
  - Environmental sustainability
  - Equal opportunities

The intermediate body will also provide advice to the managing authority to assist the managing authority to make its assessment against the following Core selection criteria:

1. Value for money; and
2. Deliverability.

Having assessed projects against these criteria the relevant local enterprise partnership area European Structural and Investment Funds sub-committee will advise the managing authority or intermediate body as relevant on the contribution to local economic growth conditions and opportunities within the context of the operational programme and local European Structural and Investment Funds strategy to aid the managing authority's assessments (at outline and full application stage).

Having concluded their assessments the managing authority and the intermediate body will prioritise the applications they wish to proceed based on their assessment against their respective selection criteria. Only projects that the managing authority and the intermediate body each agree should proceed, based on their respective core selection criteria, will be invited to submit a full application. Subsequently only

those full applications that the managing authority and the intermediate body each agree should proceed, based on their respective selection criteria, will be approved.

Please note that the managing authority's decision is final and there are no appeals. ## 6. General Information

### 1. National Eligibility Rules

When developing an application, Applicants must refer to the [National Eligibility Rules](#) setting out the requirements of the 2014 to 2020 European Regional Development Fund Programme. It is the responsibility of the applicant to ensure that the National Eligibility Rules are adhered to both at application stage and following approval. Failure to do so can lead to financial penalties leading to recovery of up to 100% of the grant value. If in doubt on any of the requirements, applicants are strongly advised to seek specialist advice.

European Regional Development Fund eligibility rules apply to **all** project spend within the eligible costs, including match funding.

The European Regional Development Fund is governed by European regulations and national rules. Applicants are advised to familiarise themselves with the relevant documentation, (Section 8 Key Document refers) prior to submitting an outline application. If successful at the full application stage, Applicants will enter into [a Funding agreement](#) and must abide by the standard terms and conditions contained therein. Once a Funding agreement has been issued it should be signed and returned within 30 days, unless otherwise agreed with the managing authority. Applicants are therefore strongly advised to read these terms and conditions to ensure that they are able to enter into such an agreement prior to responding to the call.

### 2. Eligible Applicants

Section 4 of the [National Eligibility Rules](#) sets out who is eligible to apply. Financial Due Diligence checks will be undertaken on non-public sector applicants that are



successful at the outline application stage. Checks will be carried out following notification of a successful outline application and may exclude applicants from further consideration. These checks will include assessment of the applicant's financial standing including ability to deal with cost overruns, the ability to cash flow a project in arrears and absorb a financial irregularity.

Applicants must be legally constituted at the point of signing a funding agreement. If the application is approved the applicant organisation will enter into a legally binding funding agreement and therefore will carry the liability for ensuring that the terms and conditions of the funding agreement are met.

If there is more than one organisation applying for the funds, a lead organisation must be selected to become the applicant (and grant recipient) with the remaining organisation(s) acting as delivery partner(s). In this situation the applicant would be responsible and liable for the delivery partner(s) and ensuring the project is operating compliantly.

During the application process the managing authority will consider the applicant's track record, both positive and negative. If the applicant has been involved in the delivery of previous European grants and any irregularities have been identified, the managing authority will expect to see what steps have been taken to ensure that the risk of further irregularities in the future is mitigated. It is acknowledged that some organisations will be new to European Structural and Investment Funds funding and will not have a track record.

### **3. Contribution rate and match funding**

European Regional Development Fund investment must not be used to replace existing funding sources. European Regional Development Fund investment must enable activity to take place that would not otherwise happen or to increase the scope, scale or intensity of activity. The level of European Regional Development Fund awarded will be the minimum in order for the project to proceed

The maximum contribution rate is 80% of the total eligible project costs subject to State Aid regulations.

The remaining 80% or more must come from other eligible sources as specified under section 6 of the National Eligibility Rules. During the application process applicants will need to satisfy the managing authority that they have, or are able to put in place eligible match funding for the balance of costs. Other EU funds cannot be used as a source of match funding.

European Regional Development Fund investment is limited by State Aid regulations and where the award of European Regional Development Fund would constitute

State Aid the European Regional Development Fund grant rate may fall below the 80% maximum.

European Regional Development Fund is paid quarterly in arrears and expenditure must be defrayed prior to the submission of any grant claims. Applicants may be asked to demonstrate how they are able to cash flow the operation.

#### **4. Project timescales**

European Regional Development Fund funding will normally be approved for three years; however the managing authority reserves the right to extend the contract term in exceptional circumstances.

Projects approved through this call will normally be expected to:

- Submit a detailed and complete full application within three months of formal selection at outline stage. Projects which fail to meet this deadline may be deselected;
- Commence delivery (defraying European Regional Development Fund eligible costs) within three months of formal approval. Projects which fail to meet this deadline may be deselected; and
- Be closed by June 2023.

#### **5. Project extensions**

Existing grant recipients whose projects:

1. Do not involve the direct development of premises or infrastructure under Investment Priority 2a;
2. Have a funding agreement that ends/has a financial completion date during the period of this call or within **18 months of the closing date of this call**; and
3. Addresses the priorities set out in section 2

May apply for a second phase of delivery – this will be expected to be in the same form as the current project (i.e. a genuine continuation of activity) but may reflect improvement/some change to reflect experience of the first phase of the project. The application must be made using the standard outline application form. Where changes to the first phase of the project are significant, these should be presented as a new application. The relevant Growth Delivery Team will apply judgment in considering the significance of any change. Projects may apply to be extended for up to 3 years.

Applications in respect of the development of premises or other infrastructure should be presented as new projects, this includes applications that have a link to an existing European Regional Development Fund project e.g. further phases of the development of sites or premises.

**Please note** - extensions to existing projects will be assessed against the criteria set out in this call in the same way as 'new' projects. There is no guarantee that extensions will be selected. Extension requests relating to projects that end more than 18 months after the closing date of the call or do not meet the requirements set out in this call will be rejected. The applicant's track record and the performance of existing contracts will be taken into account during the assessment process.

## **6. Capital projects**

In developing the budget for the outline application, applicants seeking European Regional Development Fund to support a capital project should note that:

1. New build projects will normally be expected to achieve the Building Research Establishment Environmental Assessment Method (BREEAM) rating of 'excellent'; however BREEAM 'very good' will be accepted where this is the maximum feasible standard;
2. Refurbishment projects will normally be expected to achieve the BREEAM rating of 'Very Good'; and
3. Infrastructure projects will normally be expected to achieve the Civil Engineering Environmental Quality Assessment rating of 'Very Good'.

## **7. Cross Cutting Themes / Horizontal Principles**

All applications selected as a result of this call will be required to demonstrate how the Cross Cutting Themes have been addressed in the project design and development. Cross Cutting Themes for European Regional Development Fund are 'equality and anti-discrimination' and 'sustainable development'. Further information is available in Section 11 of the [European Regional Development Fund Operational Programme](#).

Information and communications technology issues are likely to impact more on older people and disabled people, so digital infrastructure investments under priority axis 2 should be accompanied by relevant skills support.

## **8. Additionality, duplication and displacement**

Additionality is a core principle of European Regional Development Funding. Applicants must be able to demonstrate that the activity paid for out of European Regional Development Funding adds value to new or existing activity.

European Regional Development Funding cannot support activities that duplicate existing provision / services within the region.

Applications need to identify and evidence how the beneficiaries will use the service and demonstrate that the project does not displace other activity available in the market place.

## 9. State Aid and revenue generation

Applicants are required, in the outline application, to provide a view on how their proposal complies with State Aid law. Applicants must ensure that projects comply with the law on State Aid. Grant funding to any economic undertaking which is State Aid can only be awarded if it is compatible aid, in that it complies with the terms of a notified scheme under the General Block Exemption Regulation (EU) 651/2014.

Only if this is not possible should applicants use the De minimis regulation or 'no aid'. [Guidance for grant recipients](#), explaining more about State Aid, is available; it is important that Applicants take responsibility for understanding the importance of the State Aid rules and securing their full compliance with them throughout the project, if it is selected into the Programme.

The managing authority is not able to give legal advice on State Aid. It is the responsibility of the applicant to ensure that the operation is State Aid compliant.

## 10. Procurement

All costs claimed by the applicant (grant recipient and / or delivery partner(s)) must be recovered on an actual cost basis. Other costs must be procured in line with National (including [Public Procurement Regulation 2015](#)) and EU regulations. Procurement will be subject to audit and verification and any irregularity will result in a financial penalty of up to 100% of the grant paid. Robust and transparent procurement is required to ensure that grant recipients:

- Consider value for money;
- Maximise efficient use of public money; and
- Maintain competitiveness and fairness across the EU.

It is **strongly recommended** that applicants seek and follow legal advice in respect of procurement requirements. Procurement irregularities remain the most substantive cause of error and clawback of grants.

## 7. Support

Please note that this is a competitive call and to preserve impartiality the managing authority and, where appropriate, the intermediate body are unable to enter into correspondence with applicants over their outline application. ## 10. Document Submission

Completed outline applications must be submitted via email to the address in Section 7. Applicants are asked to quote the call reference and project name in the subject line of your email as this will greatly assist the managing authority.

Outline application forms not received by the deadline will not be assessed. Outline applications which are not fully completed will be excluded.

The managing authority will normally acknowledge receipt of your application by email. For this call applications will normally be required to **commence delivery/activity within three months** of the award of a Funding Agreement.
