Thank you for your email of 22 February 2018 requesting the following information:

"details of the documents submitted by Treetop Trek, ahead of your initial response [Attached for info], with any personal details removed if needs be?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found at enclosed as Annex A and B, but some of the information falls entirely within the scope of the absolute exemptions provided for at section 40 (Personal Data) and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

If you have any queries regarding the content of this letter, please contact this office in the first instance.

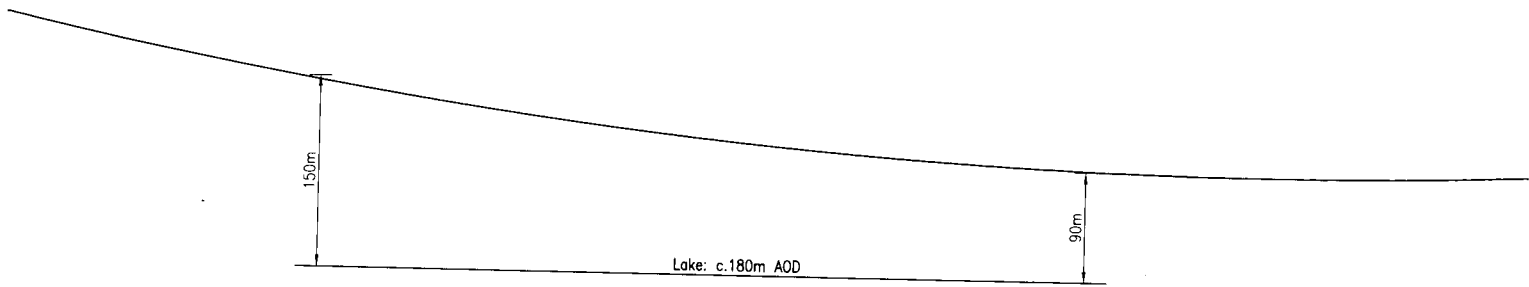

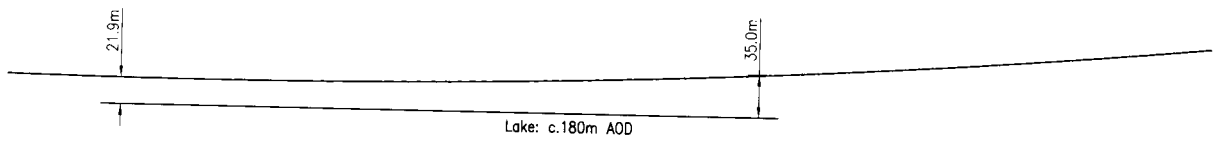
