Thank you for your email of 12 March 2018 requesting the following information:

"A breakdown commencing from when CarillionAmey was awarded the military housing contract, of the following statistics:

- 1. The overall numbers of claims for financial compensation that have been submitted by military personnel occupying Service Families Accommodation managed by CarillionAmey.
  - a) The number of these claims for financial compensation that were paid in full by CarillionAmey.
  - b) The number of these claims for financial compensation that were **not** paid in full by CarillionAmey.
- 2. I request the information set out below:

a.	A copy of the damp and mould survey carried out at on or around 5 Apr 2016.
b. tnat no	Copies of any other damp and mould surveys carried out at after 5 Apr 2016 and before 4 Jan 2018. (Or clarification other surveys have been conducted, should that be the case).
C.	Details of damp and mould treatment work carried out at between Aug 2015 and 4 Jan 2018.
d.	A copy of any damp and mould surveys carried out at between the period of May 2017 and 4 Jan 2018.
e.	A copy of any damp and mould surveys carried out at . between the period of Aug 2015 and 4 Jan 2018.

## f. Details of damp and mould treatment work carried out at . between Aug 2015 and 4 Jan 2018.

g. The specific carillionamey policy, or third-party policy adopted by carillionamey, for the treatment of damp and mould and the contractual obligations relating to the treatment of damp and mould."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).
