	HS2 presented why the references in the RTMP concerning Traffic Enforcement Notices had been replaced by AssessNet (or any later reporting requirements) as the reporting tool for any incident associated with the project, including public complaints. Details are provided on the slides sent after the meeting.	
	A number of queries arose concerning the complaints process and how issues were to be resolved, but this is a wider issue than dealt with in the presentation. HS2 Ltd to report back when these strategies have been fully published.	
	HAs suggested that the issues raised above needed to be discussed in more detail and thus ought to be included in the agenda for the next HSG meeting.

	HS2 confirmed that all immediate recommendations in the TRL report were being carried out, with certain matters to be considered as necessary in later years, such as frequency of further surveys.	
	A key issue from the ensuing discussion was why HS2 Ltd were excluding all A roads from condition surveys unless HAs can demonstrate that specific A roads are not suitable for HS2 construction traffic. This is in accordance with the RTMP.	
	The following concerns were also raised by HAs	
	 The full scope of work given to TRL had not been shared with the HAs prior to the work being carried out The assumption that all A-roads were capable of carrying Heavy Good Vehicles (and thus HS2 construction traffic) was very simplistic. A more systematic risk assessment approach to determine traffic on some routes would be more suitable HAs also disputed the examples cited in the slides which indicated that "unusual frequency of ordinary loads does not constitute extraordinary traffic" 	
	As a result of these issues, HAs suggested that an agenda item would be required to explore them in more detail. HS2 Ltd agreed to include the issue on the agenda for the next meeting, but stressed that its position was unlikely to change.
