Highway maintenance agreement

- Majority of comments concerned about liability already imposed on authorities either through the HS2 Act and/or existing duty to maintain highway
- Some comments sought wording clarification and have been accepted
- Area being considered:
 - Notification if each party has to do emergency works to its own structures and any notice periods (ambiguous at present and emergency works to highways needs further clarification)
 - Clarification on some of the definitions
- Majority of other comments have either been addressed before, or for individual discussions
- Hope to issue final version by end of next week



Temporary / permanent consents and approvals

Temporary / permanent consents and approvals

- Majority provisions in Schedules 4 and 33 Part 1 do not distinguish between temporary or permanent works
- Main reference to permanent occurs in Schedule 4:
 - Schedule 4, Part 2 paragraph 5 Permanent obstruction
- Only limited references to temporary as well:
 - Schedule 4, Part 2, paragraph 6 Temporary interference
- Most other consents / approvals can apply to both), e.g.
 - Accesses (Schedule 4, Part 1, paragraph 1)
 - Completion of works to reasonable satisfaction (Schedule 4, Part 3, paragraph 10)
 - New or realigned carriageway (Schedule 4, Part 3, paragraph 11)
 - Tunnels and bridge (Schedule 33, Part 1, paragraphs 4 to 7)
 - Property of highway authority (Schedule 33, Part 1, paragraph 9)
- Next slides indicate some scenarios and consent requirements.

Example 1 – Simple permanent carriageway realignment

Schedule 4, Part 2, paragraph 6 for temporary Interference (Form TM1) Schedule 4, Part 3, paragraph 11 for realigned carriageway (Form HW1) Notification of stopping up (Form HW3) Schedule 4, Part 2, paragraph 6 for temporary interference (Form TM1)

Form HW 1

- Form HW1 relates to Schedule 4, Part 3, paragraph 11 approvals for new or realigned carriageway
- No substantive comments received from sub-group on Form HW1
- Form content therefore remains much the same as that circulated
- Scope within form to add additional details should they be required
- NB Planning permission for the works is deemed granted by the Act, including any impacts that go with it. The Form HW1 approvals cover detailed design of highway matters, not the principle.

Form HW2

- Form HW2 relates to Schedule 33, Part 1, paragraph 6 approvals for new or altered bridges under or over HS2
- Comments to be received by 30th June 2017 NB Date to be confirmed
- Draft form to be circulated following meeting
- Scope within form to add additional details should they be required
- NB Planning permission for the works is deemed granted by the Act, including any impacts that go with it. The Form HW2 approvals cover detailed design of the structure, not the principle of a bridge or its appearance (which is covered by Schedule 17).

Form HW3

- Form HW3 provides notification about permanent stopping-up
- NB Deemed approval for stopping up granted by the Act, with no further consent required provided that one or more of the preconditions are met
- Temporary stopping, up even if for long duration, is covered by temporary interference (Form TM1)
- Draft form to be circulated following meeting
- Comments to be received by 30th of June 2017 NB Date to be confirmed

- Form HW6 Schedule 4, Application for footpaths and bridleways
- Form HW7 Schedule 4, Consent for permanent obstruction

- Form HW9 Schedule 4, Request for date of completion certificate
- Form HW10 Schedule 33 Part 1, Approval of tunnels ≤ 8m below
