

Permitting decisions

Surrender

We have decided to accept the surrender of the permit for Lambourn Woodlands Waste Oil Storage Facility operated by Slicker Recycling Limited.

The permit number is EPR/LP3030EQ.

We are satisfied that the necessary measures have been taken to avoid any pollution risk and to return the site to a satisfactory state. We consider in reaching that decision we have taken into account all relevant considerations and legal requirements.

Purpose of this document

Key issues of the decision

1.0 Reason for surrender

The operator has confirmed that the permitted activities have ceased, decommissioning is complete and pollution risks have been removed and the land is in a satisfactory condition.

Although there have been no know pollution incidents on site, the Non-Technical summary submitted with application S001 notes that one sample taken at the site centre levels of hydrocarbons were slightly raised compared with historic levels and it was agreed (with the Environment Agency) that the area surrounding the sample point (fig 1 and WS118A) would be removed for off site remediation and back filled with clean aggregate.

EPR/LP3030EQ/S006 Date issued: 15/01/2019 The Area officer confirmed in an email dated 11/01/19 hat they drove past the site on 10/01/18 and are satisfied that the surrender notice can be issued.

	Paragraph 1.3 of the guidance says:
	"The primary role of regulators, in delivering regulation, is to achieve the regulatory outcomes for which they are responsible. For a number of regulators, these regulatory outcomes include an explicit reference to development or growth. The growth duty establishes economic growth as a factor that all specified regulators should have regard to, alongside the delivery of the protections set out in the relevant legislation."
	We have addressed the legislative requirements and environmental standards to be set for this operation in the body of the decision document above. The guidance is clear at paragraph 1.5 that the growth duty does not legitimise non-compliance and its purpose is not to achieve or pursue economic growth at the expense of necessary protections.
