### **Non-technical summary**

This noise and vibration monitoring report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the London Borough of Ealing (LBE) during the month of November 2018.

The report presents data from noise monitoring installations in the vicinity of the Atlas Road worksite (ref.: S001-WS02) where site set up, hoarding and pre-demolition surveys were underway, the Victoria Road worksite (ref.: S002-WS01) where early demolition activities were underway, Willesden EuroTerminal worksite (ref.: S001-WS03) where pre-demolition surveys and crane deconstruction were underway and Old Oak Common depot worksite (ref.: S004-WS01), where demolition and groundworks were being carried out.

Given the nature and location of works currently being undertaken and the high ambient noise at many of the monitoring locations, the measured noise levels are largely dominated by the underlying ambient noise levels, rather than being attributable to HS2 construction noise.

No exceedances of the SOAEL and no exceedances of S61 trigger levels due to HS2 related works were measured during the monitoring period. One vibration complaint was received during the monitoring period, regarding perceptible vibration at a property on Stephenson Street. Following the complaint work methodology were reviewed and agreed with the Local Authority.

decibel(s), or dB	Between the quietest audible sound and the loudest tolerable sound there is a million to one ratio in sound pressure (measured in Pascal (Pa)). Because of this wide range, a level scale called the decibel (dB) scale, based on a logarithmic ratio, is used in sound measurement. Audibility of sound covers a range of approximately 0-140dB.					
decibel(s) A- weighted, or dB(A)	The human ear system does not respond uniformly to sound across the detectable frequency range and consequently instrumentation used to measure sound is weighted to represent the performance of the ear. This is known as the 'A weighting' and is written as 'dB(A)'.					
Equivalent continuous sound pressure level, or L <sub>pAeq,T</sub>	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.					
Façade	A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +2.5 to +3 dB) sound level than it would be if the reflecting surface was not there.					
Free-field	A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position.					
Exclusion of data	Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, winds speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Identifiable incongruous noise and vibration events not attributable to HS2 construction noise are also excluded.					
Equivalent continuous sound pressure level, or L <sub>Aeq,T</sub>	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.					
Peak particle velocity, or PPV	Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s.					
Sound pressure level	The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud.					
Vibration dose value, or VDV	An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s <sup>1.75</sup> .					

# **1** Introduction

- 1.1.1 The nominated undertaker is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
  - monitoring the impact of construction works;
  - to investigate complaints, incidents and exceedance of trigger levels; or
  - monitoring the effectiveness of noise and vibration control measures.

Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the London Borough of Ealing (LBE) for the period 1<sup>st</sup> to 30<sup>th</sup> November 2018.

1.1.2 Active construction sites in the local authority area during this period include:

- Atlas Road, worksite ref. S001-WS02 (see plan 3 in Appendix A)
  - Works activities include site set up and pre-demolition activities.
- Willesden EuroTerminal, worksite ref. S001-WS03 (see plan 3 in Appendix A)
  - Works activities include pre-demolition activities and deconstruction.
- Victoria Road, worksite ref. S002-WS01 (see plan 2 in Appendix A)
  - Works activities include early demolition activities.
- Old Oak Common depot, worksite ref. S004-WS01 (see plan 1 in Appendix A)
  - Works activities include demolition activities and groundworks.

### 2 Summary of results

#### 2.1 Exceedances of SOAEL

- 2.1.1 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance – Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."
- 2.1.2 Where construction noise levels exceed the SOAEL, relevant periods will be identified and summary statistics provided in order to evaluate ongoing qualification for noise insulation and temporary rehousing.
- 2.1.3 Table 3 presents a summary of recorded exceedances of the SOAEL due to HS2 related construction noise at each measurement location over the reporting period, including the

number of exceedances during each time period. For this monitoring period no exceedances of the SOAEL were recorded.

- 2.1.4 HS2 construction activities at worksites S001-WS02, S001-WS03, S002-WS01 and S004-WS01 were undertaken only between 08:00 and 18:00 on weekdays. There were no exceedances of the SOAEL during these periods at any noise monitoring location.
- 2.1.5 Noise monitoring in the vicinity of HS2 worksites in Ealing demonstrate that HS2 related construction noise did not give rise to any exceedance of the SOAEL during the core working hours in which such activities took place.

#### 2.2 Summary of measured noise levels

- 2.2.1 Table 4 presents a summary of the measured noise levels at each monitoring location over the reporting period. The L<sub>Aeq,T</sub> is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period L<sub>Aeq,T</sub> that was found to occur within the month.
- 2.2.2 Appendix C presents graphs of the noise monitoring data over the month for each of the measurement locations. Data presented includes the hourly L<sub>Aeq</sub> values and, where relevant, the L<sub>Aeq,T</sub> values (where the time period T has been taken to be the averaging period as specified in Table 1 of HS2 Information Paper E23). 2.2.3 Given the nature and location of works currently being undertaken at worksites in LBE the measured noise levels are largely dominated by the underlying ambient noise levels, rather than being attributable to HS2 related construction noise, acknowledging that intermittent HS2 works have on occasion been taking place within the area.







### **HS2** Worksite identification plan - 2






### HS2 Noise monitoring plan - 1








### Worksite: S002-WS01 – Monitoring Ref: N029
















