# WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

The Essex County Council Definitive Map Modification No. 635 (Footpath 19 Mayland,
Maldon District) Order 2017

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The start date for the above Order is 25 January 2019

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at Lawling Park Hall, Katonia Avenue, Maylandsea, Essex CM3 6AD on Tuesday 2 July 2019 at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map for the area by:

1. Adding a footpath to be known as footpath 19 Mayland, running from the northern end of North Drive, Mayland, northwards and north-eastwards along Sea View Parade for approximately 91m with a width of 3.1m, then south-eastwards with a width of 4m for approximately 105m. The path then turns eastwards and almost immediately south-eastwards and continues with a width of 2m for a distance of approximately 160m before turning north-eastwards to meet Nipsells Chase.

As Essex County Council has indicated that it will not be supporting the Order at the Inquiry, the case for the Order will be presented by Mayland Parish Council. The Parish Council will be expected to adhere to the following timetable as if it were the Essex County Council.

### Timetable for sending in statements of case and proofs of evidence

#### Within 8 weeks of the start date by [by 22 March 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

#### Within 14 weeks of the start date [by 3 May 2019]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case<sup>1</sup> is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

### 4 weeks before the date of the inquiry [by 4 June 2019]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.

This Order is made by Essex County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 "the Act" because it appears to the Secretary of State (who has directed the authority to that effect) that the Definitive Map and Statement for the County of Essex requires modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows (i) that a right of way which is not shown in the map and statement is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Essex County Council hereby order that:

- 1. For the purpose of this order the relevant date is 30 November 2017.
- 2. The Definitive Map and Statement for the County of Essex shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This order shall take effect on the date it is confirmed and may be cited as the Essex County Council Definitive Map Modification No.635 (Footpath 19 Mayland, Maldon District) Order 2017.

A footpath, to be known as footpath 19 Mayland, running from the northern end of the adopted road, North Drive with a width of 3.1m northwards and north-eastwards along the unadopted Sea View Parade ( $\mathbf{A} - \mathbf{B}$  on the Order plan), then turning southeastwards on the south-western side of the boundary with a width of 4m before crossing to the north-eastern side of the boundary ( $\mathbf{B} - \mathbf{C}$  on the Order plan), continuing easterly then north-eastwards, with a width of 2m to exit onto Nipsells Chase ( $\mathbf{C} - \mathbf{D}$  on the Order plan).
