01/02/15 The Chairman welcomed everyone to the meeting introducing Chris Kitchen

07/02/15	Members suggested the addition of Regulation Committee Effectiveness Review to the March workshop.	СК
08/02/15	Members NOTED the forward planner.	
6	Regulation Director's update on key issues	
10/02/15	VFM downgrades – Members were advised that as at February 2015, eight providers did not provide sufficient assurance against the standard. Four providers had their governance rating downgraded from G1 to G2. Members NOTED the other providers who had been issued with regulatory judgements or notices. Members suggested that officers check that stakeholders understand the significance of providers being issued with regulatory notices.	JW
11/02/15	Global Accounts – Members were informed that the Global accounts would be published on 18 March 2015 and noted the key points. Net surplus has risen, and the message from the regulator is that the majority of the surplus has and will continue to be re-invested in fixed assets including supply of housing.	
12/02/15	Quarterly Survey – 47 providers were contacted in respect of MTM exposure.	
13/02/15	Framework Publication – Members were advised that the framework had been well received including Moody's, who noted that the framework was credit positive. There had been one specific issue raised by ALMOS which was addressed separately on the agenda.	
14/02/15	Legislation update – stakeholder engagement had been positive. There is to be a workshop with CML panel members in April. Positive discussions continue in respect of lead options and timing of advice to ministers.	
15/02/15	NHF Code of Governance – Members were informed that the new Code of Governance had been published by the NHF. The new code is taking a more holistic view to CEO remuneration including the expectation that CEO's contracts are reviewed at least every three years.	
16/02/15	Select Committee – Members were advised that the letter had been sent and there had been no response to date.	
18/02/15	Regulatory Judgements – the three governance downgrades were NOTED.	
19/02/15	Media Coverage & Stakeholders – the Regulatory Framework and the VfM downgrades attracted some media coverage. Stakeholder engagement meetings were proving very helpful. Regulation Committee to see a revised comms strategy when complete.	JW

36/02/15 Regulation Committee AGREED the registration of Shrewsbury Drapers.

## 12 Regulatory Judgements

37/02/15 Members NOTED that eighteen regulatory judgements were published on the Agency's website in January. The Deputy Director Regulatory Operations informed members that nine judgements were straightforward and would retain their G1/V1 straplines. The remaining four providers were given governance upgrades to V1, based on the improvements identified through their VfM statements.

- 38/02/15 Members were advised that there had been six viability judgements in January, four confirmed as V1 and two which were V2.
- The in-depth reports on the four cases in Annex 1 were reviewed and the outcomes and grading were NOTED by the Members.
