## 3 Minutes of the meeting held on 16 September

03/10/14 The minutes of the meeting were AGREED as an accurate record of the **SLS** meeting subject to minor amendments

- 05/10/14 The Director of Regulation informed members that good progress was being made on the protocol with HCA-i. Members asked that the Protocol should come to Regulation Committee before being finalised for sign-off by the HCA **IF** Board.
- 06/10/14 Members NOTED the matters arising.

## 6 Regulation Director's update on key issues

- 08/10/14 The Director of Regulation updated Committee on key developments since the last Committee meeting. Particular note was taken of the following points.
- 13/10/14 Accounting Direction/IFRS Members noted an update on FRS102 & SORP 2014 which will become effective from January 2015.. Members raised the possibility of including a question in the Quarterly Survey on covenants. The Director of Regulation confirmed that this was already included in the QSR and officers were updating the survey for the coming year.
- 14/10/14 Rent to Buy / London Housing Bank Members were informed of the Government's new £400m affordable rent to buy products which would be run by the HCA and GLA. The prospectuses have been launched and assessment of the bids will begin on 12<sup>th</sup> November. The Regulator will be reviewing bids to check ongoing compliance with The Viability Standard using similar approach to other bidding rounds and would provide an opinion to HCA-I in line with the existing protocol.
- 15/10/14 Media Coverage The Director of Regulation provided an update on media coverage and stakeholder engagement and the plans to increase engagement in the coming months.

17/10/14 Members NOTED the report.

### 7a Regulation Framework

- 20/10/14 Members received a report which provided a summary of the proposed course of action following analysis of consultation responses on changes to the regulatory framework.
- 33/10/14 Members discussed a number of outstanding issues that had been identified in the feedback. They noted that these would be taken away and the resolution brought back to a future committee meeting.

- 47/10/14 Following a discussion at the previous Committee meeting, members received a report outlining the suggested priorities proposed for the project to review the HCA's statutory powers, which Ministers have committed to following the lessons learned review of the Cosmopolitan case.
- 48/10/14 Members noted that this was a joint project with DCLG and AGREED with the proposed priorities.
- 49/10/14 Members noted that they would receive a presentation at the November **JB** meeting, which would outline plans for stakeholder engagement.

### 9 Private Finance Strategy

- 50/10/14 Members considered a refreshed Private Finance Strategy which had been updated to reflect the diverse and complex nature of the private finance market in social housing sector.
- 51/10/14 Members considered the draft strategy and suggested a range of measures to improve the flow of information and intelligence including improved transparency on the Government's website (<u>www.gov.uk</u>), processes on internal information handling such as selective disclosures and a Q&A on the website.
