## Codes of Practice - Authorisation of Certifying Authorities

**Notice to all Owners, Operators and Skippers of Small Vessels in Commercial Use and Certifying Authorities of this type of Vessel.**

### Summary

The purpose of this Marine Information Note is to provide the revised contact details of the MCA authorised Certifying Authorities undertaking survey and certification work against the standards of the Small Commercial Vessel Codes of Practice, Police Boat Codes or MGN 280 (M)

## 1. Introduction/ Background

1.1 .Certifying Authorities undertake survey and certification work under the Small Commercial Vessel Codes of Practice or MGN 280. The Codes of Practice are as follows:

- The Safety of Small Commercial Sailing Vessels – A Code of Practice (Blue Code)
- The Safety of Small Commercial Motor Vessels – A Code of Practice (Yellow Code)
- The Code of Practice for the Safety of Small Workboats and Pilot Boats (Brown Code)
- The Code of Practice for the Safety of Small Vessels in Commercial use for Sport or Pleasure Operating from a Nominated Departure Point (NDP) (Red Code)
- The Police Boat Codes (A, B, C, D)
- The Police Boat Code (PBC3)
- The Code of Practice for the Safety of Small Workboats and Pilot Boats (Industry Working Group Technical Standard)
- The Code of Practice for the Safety of Small Workboats and Pilot Boats. Edition 2
- MGN 280 (M) – Small Vessels in Commercial Use for Sport or Pleasure, Workboats and Pilot Boats – Alternative Construction Standards is available as an equivalent standard to the Small Commercial Vessel Codes of Practice.



## 2. Responsibilities

- 2.1 Certifying Authorities are authorised by the Maritime and Coastguard Agency to examine and certificate small commercial vessels in accordance with the applicable requirements
- 2.2 A Certifying Authority is responsible for each certificate it issues, and the relationship between the Certifying Authority and a vessel owner / managing agent is direct. This does not supersede the Code requirement that an owner is responsible for ensuring his / her vessel complies with the requirements applicable to that vessel.
- 2.3 It is the responsibility of the owner / managing agent to ensure that a vessel is properly maintained, examined and manned in accordance with the relevant Code.
- 2.4 The following Certifying Authorities are authorised as Inspectors of Marks for the purpose of completion of Carving & Marking Notes, on UK ships of less than 24 metres in length.
- 2.5 The following Certifying Authorities are authorised to undertake inspections in accordance with the Maritime Labour Convention, on Coded vessels of less than 24 metres in length.
