Thank you for your email of 5 January 2019 requesting the following information:

*"All the information the MOD has about the illegal tipping of waste on land next to the Pirbtght rangers from 1987 to 01 January 2019."*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found enclosed below but some of the information falls entirely within the scope of the absolute exemptions provided for at sections 40 (Personal Data) of the FOIA and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the General Data Protection Regulation and Data Protection Act 2018. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

Please find the information you requested below in the format that it was inputted in to the system for reporting such incidents.

02/11/2016 10:00:00- Fireworks found on the E3 area by the car park off the Goal road - Fireworks had all been used and were just general rubbish. NSC reference number - 78191.

21/11/2016 09:49:00 - [REDACTED] reported that whilst walking her dog on E3 she has come across left over and used fireworks by the car park on Goal Road. Reported to the Ops room, this information has been passed onto the NSC (case number: 79834) and they will update us when this waste has been removed.

13/01/2019 15:00:00- Discovered by [REDACTED] 50 Kg of "Fly Tipped" builders waste. Area E3 (Stoney Castle) - Removed from site by TAO. Area clear.
