Thank you for your email of 29 March 2018 requesting the following information:

"You kindly provided the below information in November last year, in response to a Fol request l submitted in September. Under the Fol act, please can you supply the same information for 2017-2018 (to date) so I have the most up to date data set?

(How many MoD buildings or parcels of land have been sold in each of the following years: 2013, 2014, 2015, 2016, 2017 (to date)?

Please provide the location (or postcode, whichever is easier) and a short description of the property type (e.g former army home, Catterick barracks) or land.

How much money did the MoD make in total from the sales of building/land?)"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some of the information in scope of your request is held.

The information relating to MOD Buildings or parcels of land sold in 2017/18 including location, postcode and a short description of the property type can be found at Annex A.

However the request for the amount of money the MOD made in total from the sales of buildings/land for 2017/18, has being withheld under Section 22 (intended for future publication).

Section 22 (intended for future publication) of the FOIA applies when the information is held with a view to publication at the time the request for it was received. Section 22 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 22 has been applied because all of the information requested is information that the department holds with a view to its publication. The balance of the public interest therefore lay in

withholding this information you desire as the department intends to release this information into the public domain at some future date.

If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.gov.uk</u>). Please note that any request for an internal review should be made in writing within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
